An application can be increased before approved. It advances the priority but nobody else on creek filed in between so not a big deal. You can amend the appl by (a) filling out a replacement appl & label it "amended," or (b) making an appointment here to fix it on the original appl.

Regarding processing, the dept needs to have internal discussion on the information resulting from the water district meeting, there's some concerns I had not thought of when we last talked. Lots going on in Castle Creek:

- Water district where expect controllable & measureable diversions
- Recent approval of changes to old rights (SV Ranch Transfer 76740) & approval of new permit (SV Ranch 57-11794) where a number of controls are mandated & form the basis for approving those proposals
- New applications for more water & new uses, where any approvals would be expected to have mandated controls.

Sounds like the Castle Creek users want waivers to all those situations. That's going to take some discussion before responding to the folks.

Have attached some information from SV Ranch approvals. Note that also involved creek rights being diverted downstream from Snake River pump, which means the Snake River Watermaster would need data to make the right decisions on the river.

At our recent district meeting, we discussed at length the concerns outlined in your letter. Obviously, as the ones who depend on water from Castle Creek to drive our operations, we are also extremely interested in the proper administration of our water rights. As a district, we discussed some concerns of our own, reached some conclusions, and also took some actions in an effort to improve the management of water from Castle Creek.

One major concern is the volume of flow at certain times of the year. Notwithstanding the last two years, creeks like this can experience extremely high flows, either during spring run-off, or during cloudburst events at other times of the year. Keeping a measuring device in place during these conditions is extremely difficult, if not impossible.

We acknowledged that the measurements and estimates of flow made by the Water Master for the purpose of satisfying the various water rights may not be completely accurate under all conditions, but agreed that he would use the best tools and experience that he could, and the water users would have to accept his judgment and discretion. We affirmed this agreement as a resolution included in the minutes of that meeting.

However, also affirmed by resolution, was the right of any party that felt aggrieved as to the water distribution by the Water Master, to install and maintain, at his or her expense, an approved measuring device from which the Water Master must use to obtain the measurements for that diversion.

Another measure that we took, in an effort to be proactive toward an issue that has been somewhat of a trouble spot over the last few years was to notify by letter those water users who have storage rights from Castle Creek as to the dates that they may divert water to storage without regard to prior irrigation rights, and when those unregulated diversions come under the rules of the irrigation season of use.

Something that has helped immensely is the information that you have supplied to the Water Master and to the water users of the district regarding the delivery priority for each water right and the irrigation season of use. Having each water user know and understand where his or her water right stands in regard to other water users is a large part of the management challenge.

In summary, it appears that the cost and effort to install and maintain lockable measuring devices do not offer enough of a benefit to change the system under which we are now operating. As long as the water users in the district can agree and get along to administer their water rights in a cooperative manner, we don't feel the need to require lockable, measurable headgates.

The Idaho Department of Water Resources (IDWR) seeks your help for improved management of Castle Creek water. Improvements in this regard will provide better certainty and efficiencies for all users, regardless of their priority dates.

IDWR is charged with striking the right balance between protecting senior water and assisting with maximum economic development of the water resources of the state. Improving management tools for the Castle Creek system will help water users protect their rights and achieve maximum beneficial use under their rights.

At this time, it is not possible for the Watermaster to physically regulate Castle Creek water rights. Adjustable, lockable diversion works and measuring devices are needed to verify water rights are being diverted and used under the priority system. These improvements would also provide a credible basis to determine if more water is available for new rights at particular times of the year (off-stream storage filled during the winter, for example).

IDWR would like to work with you to develop and implement a plan along these lines. Your annual water district meeting early next month will be a good chance to discuss this and decide what to do. RESOLUTIONS ADOPTED AT THE ANNUAL MEETING OF THE WATER USERS OF WATER DISTRICT No. 57-C FEBRUARY 2, 2015

BE IT RESOLVED: That the amounts payable by each water user, as shown by the approved budget, shall become due and payable on April 1, and that said amounts, if not paid shall bear interest from that date until paid, at the rate of eight percent per annum.

BE IT FURTHER RESOLVED: That no water user shall have the right to demand and receive water, and the Watermaster shall not deliver to such a person until the amount due and payable for such user, as fixed by the budget, has been paid.

BE IT FURTHER RESOLVED: That waterusers will after the first callout of the watermaster each season, shall be assessed \$50.00 for each callout. The Watermaster shall visit up to four times per callout.

BE IT FURTHER RESOLVED: That in maters of water distribution, when there is no approved measuring device in place, that measurements and estimates of flow made by the Watermaster will be definitive. Should any Wateruser deem that the measurement or estimate of flow made by the Watermaster is inaccurate, then that Wateruser may at his or her own expense, install an approved measuring device from which the Watermaster shall obtain measurements.
