  - Nick Nettleton reads the meeting minutes from last year as well as the adopted resolutions
    - o Brian Collett moves to approve the minutes

  - o Steve and I introduce ourselves
  - No other new business
- 1:45: -Election of officers
  - Brian Collett moves to keep officers the same (Blaine Collett Chariman, Nick Nettleton Secretary/Treasurer)

  - Members agree to keep credentials committee the same (Cal Low, Mike Lewis, and Mike Ihli)

    - Watermaster said that would work well for him, other users agree that they don't have any concerns
    - O Should be ok from an IDWR perspective as long as watermaster and other water users are not concerned

## RESOLUTIONS ADOPTED AT THE ANNUAL MEETING OF THE WATER USERS OF WATER DISTRICT No. 57-C FEBRUARY 1, 2016

BE IT RESOLVED: That the amounts payable by each water user, as shown by the approved budget, shall become due and payable on April 1, and that said amounts, if not paid shall bear interest from that date until paid, at the rate of eight percent per annum.

BE IT FURTHER RESOLVED: That no water user shall have the right to demand and receive water, and the Watermaster shall not deliver to such a person until the amount due and payable for such user, as fixed by the budget, has been paid.

BE IT FURTHER RESOLVED: That waterusers will after the first callout of the watermaster each season, shall be assessed \$50.00 for each callout. The Watermaster shall visit up to four times per callout.

BE IT FURTHER RESOLVED: That in maters of water distribution, when there is no approved measuring device in place, that measurements and estimates of flow made by the Watermaster will be definitive. Should any Wateruser deem that the measurement or estimate of flow made by the Watermaster is inaccurate, then that Wateruser may at his or her own expense, install an approved measuring device from which the Watermaster shall obtain measurements.
