Water Users in Attendance: Robert Hall, Mary Hall, Jim Chambers, Rocky Trail, Rich Wootan, Alan Crane, John McCallum, Teresa McCallum, Rob Whitney - IDWR.

Reading of Minutes:

Teresa presented the January and February minutes, these were approved as submitted by unanimous consent.

Treasurer's Report:

Teresa reported that there was \$1845.87 collected in 2014, there are two users unpaid. Income of interest of \$1.10. Expenses for 2014 were insurance \$161.00, Postage of \$44.57, Watermaster salaries paid in 2014 were. \$1350.00 for 2013 and \$1050.00 for 2014.

Water Report: There were 14 callouts in 2014. Rocky stated that he had a concern about one delivery on April 7, that Dick Anderson received water above his priority date. Rich said that it happened early in the season and understands better now how to make deliveries.

Old Business:

Rocky Trail asked Water Resources if the Diversions being, lockable and measurable by March 1st was going to be enforced this year. Rich Wootan said he has had a few requests for review. Additional discussion was held regarding Paul Batruel's diversion and the fact that it removes the creek from the original channel and should be changed back. Also that it still not accurately measurable, and unable to deliver in proper priority. Rob Whitney said he would again call Paul.

Discussions were had regarding those diversions that draw straight from the Snake River. Rob Whitney indicated that the Watermaster from the River would need to coordinate with Rich to insure that there is in fact water available in Little Canyon Creek to be drawn by Snake River pumps that are metered. Also it was asked if it would be possible to measure a weir in bulk for those users pumping out of the River. Bob Hall was wanting to find a place up stream to measure due to meandering of the creek.

On 1/29/2015, IDWR's Western Region Office issued a preliminary order requiring controllable diversion works and measuring devices for diversions on Little Canyon Creek. This order required plans detailing the controllable diversion works and measurement devices be submitted to the Watermaster for review by August 1, 2014. The order stated identification and inspection of diversions by the Watermaster shall occur on or about March 15, 2015. IDWR has assisted the watermasters with this inspection process for other district with recently issued measurement orders including Hornet Creek and Pine Creek in basin 67.

The following field work is requested:

- Accompany Watermaster Rich Wootan to each diversion.
- ➤ Identify the diversion owner and applicable water rights.
- > GPS the diversion site.
- > GPS and document type and operational status of measurement device as site.

Nick - Coordinate directly with Rich Wootan regarding meeting date, time and place.

Following the field work/site visits, prepare a summary of findings including a map.

Little Canyon Creek measuring device at mouth of creek

Hello Folks:

I understand from talking &/or emailing with you recently that there is some concern about the measurement order issued by the department (IDWR) last year for Little Canyon Creek water rights. The particular item of concern is measuring the amount of water at the mouth of the creek to verify it is sufficient to divert your rights from your Snake River pumps. This email is to let you know IDWR intends to coordinate with you and the Watermasters for Little Canyon Creek & the Snake River regarding this requirement. A single measurement method should suffice for everyone — no need to double up with more work & expense in this regard.

The order required the work to be completed earlier this month, followed by a Watermaster & IDWR inspection. This office is running behind schedule due to significant and unexpected staff turnover, more than 50%! It's only fair to allow more time for water users to complete this work if needed. As long as people are working on it &/or waiting for IDWR participation, as in this case, there should be no need to worry about reasonable delays. The only exception is someone making a delivery call to the Watermaster but not yet complying with the order. The Watermaster will not be able to deliver water to that person. This should not be a problem for your rights located at the bottom end of the creek.

As soon as things settle down on this end, we will be in touch and work with you to get this job done. I appreciate your patience until then.





FINDINGS OF FACT

- 1. The water rights on Little Canyon Creek in Elmore County Idaho are regulated by the Little Canyon Creek Water District #61D. The Water District Watermaster is responsible for water delivery and regulation of the natural flow and storage water rights associated with the creek source.
- 2. Recent annual low snow packs and rainfall has forced the Watermaster to curtail junior priority date storage and natural flow water rights early in the season to prevent injury to senior priority rights.
- 3. During 2013, there were allegations and conflicts regarding the delivery and regulation of storage and natural flow creek rights among the waterusers. There were similar delivery problems in previous years.
- 4. Measurement devices and controllable-lockable diversion works are lacking or in disrepair on the creek. The Watermaster is forced to make water deliveries based on visual flow and storage estimations.
- 5. The Watermaster cannot effectively deliver/regulate the creek water rights in the absence of measurement devices and controllable-lockable diversion works.

CONCLUSIONS

1. IC§42-701states in part:

controllable works and measurement order

- 2. The Idaho Department of Water Resources Director (Director) is authorized to supervise the distribution of water rights in a water district. Water rights are to be distributed base on priority date, ref. Idaho Code (IC) §42-602.
- 3. Failure to compete the work within the time set may warrant a notice of violation for each diversion point and/or measuring device point not in compliance with the requirements of the water district. Civil penalties should accrue starting from the time set for completion and may be levied up to \$150.00 per day for each day of the continuing violation, ref. IC§ 42-1701B.
- 4. The waterusers should be allowed ample time to complete installation of controllable diversion works and measurement devices.

ORDER

The following is hereby **ORDERED**:

- 1. Controllable-lockable diversion works and measurement devices shall be installed on utilized points of diversion as described by water rights with Little Canyon Creek as source. The deadline for approved installations/repair is on or before **March 1**, **2015.**
- 2. Controllable diversion works and measurement devices shall be subject to the approval by the Department of Water Resources and the Little Canyon Creek Water District #61D Watermaster. Measurement devices must meet the Department's "Minimum Acceptable Standards for Open Channel and Closed Conduit Measuring Devices Guide" A plan detailing the controllable diversion works and measurement device design and installation/repair will be submitted to the Watermaster for review on before August 1, 2014.
- 3. Identification and inspection of diversions by the Watermaster shall occur on or about March 15, 2015. A GPS location will be established to confirm each diversion and the associated water right(s).
- 4. Storage facilities shall be fitted with gauging that depicts the height of storage (feet) in relation to the volume (acre feet) of water being stored. The storage right holder shall provide the Watermaster a gauge height verses storage volume chart/graph for their storage facility.
- 5. A creek channel weir shall be installed upstream of the Trail Diversion Reservoir, and the downstream creek channel weir shall be repaired just downstream of the reservoir spillway to provide accurate delivery of creek natural flow water rights.
- 6. The Watermaster shall refuse/deny delivery of water to any water right holder not demonstrating an approved controllable-lockable diversion works and measuring device.

*

- 7. Failure to install an approved controllable diversion works and measurement devices by March 1, 2015 may warrant a "Notice of Violation" from the Department of Water Resources for each point of diversion not in compliance.
- 8. Authorized stockwater and domestic beneficial uses are exempt from measurement device requirements.
- 9. The Order applies only to diversions located on Little Canyon Creek. This Order is not applicable to points of diversion on ditches, lateral ditches, shared rediversions, or field headgates.
- 10. The Watermaster will deliver/administer natural flow and storage rights by priority date pursuant to IC Title 42, Chapters 6 & 7 and authorized water right parameters.
