- The water users of Smith Creek 63B met at the home of the Water master, Randy Davison on March 3rd, 2015. Those attending the meeting were Randy Davison, Sandy Davison, Kenny Davison, Luther Cook, Mike Davison, Nicole Davison, and Barb Ireland.
- The Secretary read the minutes from the 2014 meeting and gave the bank statement total of \$915.88. A motion was made to approve and second the minutes.
- The officers are as follows: Water master-Randy Davison, Chairman- Kenny Davison, Secretary- Sandy Davison, Advisory Board- Steve Ireland, Bill Davison, Representative, Credential Board- Ron Davison, Mike Davison, and Luther Cook. A motion was made and seconded to keep the officers the same.
- The canal needs to be cleaned from Ireland's to the Russell's this spring sometime and also there is a lot of ash in the canal that needs to be cleaned out due to the fire of 2013. There was also a discussion about Aden Creek, the willows need to be cleaned out so the water can flow through without washing out.
- Randy reported that he registered Smith Creek 63B with the county on line. We had to register or get a \$5,000.00 fine.
- A motion was made and seconded to adjourn the meeting
- Water master salary is \$25.00 per day for a total of five days when called out. After five days the person who calls the Water master will pay the Water master's salary. Water master is to check with the secretary when called out. Water district will pay the Secretary \$25.00 a year for expenses if the Water master is called out.
