Indian Valley Visit

I visited Indian Valley on August 14, 2015, in response to some complaints the Department had received regarding the delivery of water in Basin 67A. The valley stores water in the Ben Ross Reservoir (67-2385) which the Little Weiser Irrigation District (LWID) manages. Water users on the Little Weiser River system exchange water rights for the delivery of storage water in late summer months. Water for this reservoir is mainly diverted from the Inlet Ditch and possibly a small amount from the Richardson Ditch. These are the two furthest upstream ditches on the river.

Complaints were received regarding the lack of water delivered to the American Lindsey Ditch. This is the third ditch on the river below the Richardson and Inlet ditch. It is important to note that the American Lindsey Ditch is above the outlet from the reservoir, and does not receive storage water. The American Lindsey Ditch carries water rights senior to the two ditches up river.

Basin 67A Watermaster Joe Steppich stated this had been a trying season and that there were folks unhappy with the LWID board members and users on the Richardson Ditch. Mr. Steppich suggested that support by the Department was very useful and a visit may help resolve some of the basin's issues.

Communication with users on the American Lindsey Ditch was led by Jeff Glemser. Jeff expressed urgency that the Department observes how water was being diverted out of the Little Weiser River before the weekend started when a change in water delivery was to be made.

I spoke with Wayne Burkhardt who is a member of the LWID and being accused of "taking" water. Mr. Burkhardt expressed great displeasure of the short timing of the meeting and felt that more time would be required to gather all of the board members together for such a meeting. Mr. Burkhardt had the opportunity to meet with our group Friday to express his interest in the water although he chose not to do so. Because this was a preliminary visit to observe and assist the Watermaster, I continued on with my visit.

I was met at the LWID building in Indian Valley by Joe Steppich, Jeff Glemser, and Ron Dunham. Our visit started with the Little Weiser River weir. This is a 20' rectangular weir used to measure all water available in the River. We observed 2.25" passing over the weir. According to the Water Measurement Manual, this translates to just under 5.5 cfs. This rate cuts users on the Little Weiser River junior to 5/1/1881.

Next stop was the Richardson Ditch which has a 5' rectangular weir. At the time of the visit, 5" of water was passing over the weir, equivalent to 4.46 cfs. The most senior right on the Richardson ditch is 6/1/1895 priority which includes Mr. Burkhardt. Joe Steppich reduced the headgate flow at this time to 1.37 cfs for the delivery of storage water exchange.

At the time of my visit, water was not being diverted into the Inlet Ditch. The Watermaster was not aware of any measuring device on this ditch. The LWID later stated that there is an inverted weir on the headgate.


Last stop on the visit was the American Lindsey Ditch. There was 3.25" passing through a 6' weir converting to 2.78 cfs. Mr. Glemser stated that the flow was up from where it was earlier in the morning which he attributed to the reduction made in the Richardson Ditch.


After visiting the measuring devices on these systems, it was found that the out of priority delivery of water rights in the Richardson Ditch was causing injury to senior water users downstream. Mr. Steppich was very grateful for the visit, as it showed him a better way to separate what is being delivered to the water rights in priority and what is being delivered as a storage water exchange.


At the close of our field visit, our group was greeted by board members Jerry Jager and Isaac Ward. These gentlemen passionately expressed their displeasure with the business being conducted on this day and felt that proper notice should have been given to coordinate a more formal meeting. I expressed regret for the short notice and suggested that we move back to the LWID building in an attempt to bring both parties together and come to an understanding.


All parties reconvened back at the LWID building and I explained the findings from the day's visit. The Board members expressed the way that water has been delivered in the past was that when the reservoir opened up, everyone then exchanged water rights for storage water shares until the reservoir went dry. It was explained that the unique situation of exchanging storage water above the reservoir still required the delivery of river water in priority to senior water users above the reservoir outlet. Board members expressed that they were unaware the Little Weiser River flows were down to 1881 priority. Both parties were in agreement that a better list which seperated both the adjudicated water rights from the benefited acres for storage was in order to assist the Watermaster deliver the water appropriately.


In conclusion to my visit, I would suggest that the list of water rights within Basin 67A sorted by priority be followed more closely by the Watermaster. The water passing through the Little Weiser River measuring device dictates what is available to pass through the ditches. At the end of our meeting, both parties were in agreement of this and open to communicating with each other better to execute such a practice.

- 16 Attendees: Dean Dunham, Ron Dunham, Joe Stippich, Jerry Jaeger, Ray Turnbull, Jim Buchanan, Victor Ward, Ralph Yantis, Tony Morgansen, Isaac Ward, Ron Jaeger, Jeff Dunham, Ron Ray, Larry Boehm, Royce Schwenkfelder, & Jeff Glemser. No Idaho Water Resource Board personnel were present.
- Meeting was called to order by Royce Schwenkfelder and opened for nominations for Chairman and Secretary/Treasurer.
  - Chairman Royce Schwenkfelder Approved
  - o Sec/Tres Jeff and Angela Glemser Approved
- Minutes of last year, 2014, were read by Jeff Glemser Approved.
- Treasurer's report submitted by Angela Glemser and read by Jeff Glemser Approved
  - o Income was normal for average year of approximately \$7000.
  - 67 A water district paid for election advertisement for LWID in 2014. LWID will reimburse 67A for \$29.70.
  - Annual financial audit to be done as requested by the board. 2014 completed on 020615 by US Bank with no discrepancies.
  - Jeff and Angela Glemser to be paid \$500 for 2014 Sec/Tres work and same for 2015 - Approved
  - Water district financial report required by Idaho State House Bill 560 to be submitted electronically on the state web sited by 030115. Completed 022715.
- Credential Committee members nominated, present, and approved:
  - o Jim Buchanan, Ralph Yantis, & Ray Turnbull
- Advisory Committee members nominated and approved:
  - o Gordon Wilkerson, Ralph Yantis, Russell Mink, Royce Schwenkfelder
- Old business:
  - Joe Stippich presented a watermaster's report which was discussed by all who attended.
  - Royce Schwenkfelder commended Joe for doing a good job in getting water to everyone in 2014.
  - Joe Stippich advised that the canal bank was raised at Darren Coriell's and the canal at Mike Johnson's needed to be fixed better.
  - Joe Stippich advised that it was the most difficult to get water to everyone during July between the 4<sup>th</sup> and 10<sup>th</sup>. He further advised that it appears that





water is disappearing in the middle of the district and asked for suggestions to remedy the situation.

- Jerry Jaeger suggested that Joe be more cognizant of the water situation and anticipate what will be needed and when.
- o Ray Turnbull advised that more communication is needed with Joe Stippich.
- Joe Stippich suggested that there are problems with the lower end of the water district not getting the water as it seems to disappear in the middle of the canal system and may be due to the lack of "recharging." He believes that it may be the sprinkler systems in the lower end the district that do not allow the water to sub through the ground and back into the river for reuse, where flood irrigation does recharge the river (i.e. canal system). He further commented that he knows the canals are full until the middle of the district and then the water starts to disappear.
- O Jeff Glemser asked Joe Stippich if he needed help, such as a second person that he could train, who would also cover for him in time of illness or for time off. Joe didn't know if it would help and suggested it would be up to the water users to pay for a second person. No motion made.
- Royce Schwenkfelder opened nominations for Watermaster.
  - Watermaster Joe Stippich Approved.
  - The motions were made to pay Joe Stippich his standard pay of \$4000, phone bill, government set mileage of .57 cents per mile, and the fuel for his fourwheeler – Approved.

#### - New business:

- Victor Ward and Dean Dunham brought up the suggestion of putting a weir in the river on Bob Elias' property to ensure the lower end of the water district was getting their water.
- Ray Turnbull, Royce Schwenkfelder, Jerry Jaeger opposed putting a weir in as they believed it would not help and would be costly.
- Dean Dunham countered that a tremendous amount of water is coming down from the upper end of the district and then disappears at the middle of the district; and the weir would tell us where the water is going.
- Jerry Jaeger suggested that 60% of the water from flood irrigation goes back into the river for reuse, as sprinkler irrigation causes 40% of the water to evaporate and no water goes back into the river. Thus, as water irrigation systems improve, more water is lost.
- Isaac Ward commented that 40 to 50 years ago he remembers the reservoir was not empty at the end of the season because we had a lot more water in the river. He added that we do not have the water in the system as we did back then.
- Dean Dunham suggested that a weir would begin to find out where the problem is, whether it's the upper end verses the lower end of the district.



- Royce Schwenkfelder and Jerry Jaeger believed that the weir would not help, and the communication between people would solve the issue.
- Joe Stippich reiterated that the river needs to be recharged which is not happening as much in the lower end of the district due to sprinkler systems.
- Royce Schwenkfelder suggested adding 10 feet to the reservoir for everyone's benefit.
- Jeff Glemser suggested to make a mechanical device to measure the water to find the area(s) where the problem is without affecting the course of the river.
- Isaac Ward believed that putting a weir in the river would slow down the flow and delivery of water, and would cause a flood liability.
- Jerry Jaeger advised that the reservoir is approximately 1.27 acre feet per acre which possibly gives 30 days of added irrigation when it was originally built.
- Royce Schwenkfelder believes that the district is not using the tools already in place (i.e. weirs) appropriatly to measure water and did not believe another weir would help.
- No resolution was settled upon.
- Motion to set the assessments for the year.
  - O Same as last year, assessments set at .38 cents per cfs. Approved
- Jeff Glemser advised it is a continual issue trying to find out who owns properties when the properties within the district are exchanged between people. The only recourse is to turn the water off for those who do not pay per Idaho Water Resource Board.
- Motion made for next annual 67A Water District meeting.
  - o First Monday of February of 2016 (020116) Approved
- Meeting was adjourned at 1530 hours.
