Dear Mr . Swendsen:

At an open meeting held in the Court House at Idaho Falls on Monday, September 29 and attended by Messrs. F. A. Banks, D. H. Blossom and J. H. Thomson, the members of the special finance committee appointed by you to represent the water users of District No. 36, the Directors of the Farmers' Protective Irrigation Association and a number of representative water users from both the North Fork and the upper main river in addition to Mr. Empey and myself, a resolution was passed to the effect that it was the sense of the meeting that in view of the decreased need for irrigation water and in order to cut down the administration expense, the services of the river riders and deputy water masters should be discontinued at the end of September but that the services of the water master, Mr. John Empey, should be continued during such portion of the month of October as might seem necessary.

Following this meeting a circular letter was sent to representatives of the different conal companies in the upper valley. A copy of this letter is included herewith for your information.

Daily reports of the river situation will, therefore, no longer be prepared and during the next week the time of the remaining organization will be largely occupied with the preparetion of such data as are necessary in order to prepare the annual report of the water master. Since the county commissioners of many of the counties meet and allow bills only once in three months, and one of these meetings comes on October 13, 1919, it is desirable that this report be prepared, approved by you and submitted to the respective counties on or before the preceeding Saturday (October 11) as required by law in order that these bills may be acted upon and the money made available with which to reimburse the Normal Flow fund which was advanced by the two Twin Falls Companies and by the two water users associations of the upper valley. There is a large amount of work involved in the preparation of this report but if arrangements can be made to get quick action in your office, probably on October 10, or somer if we can get it ready at an earlier date, I believe it will be possible to get it into the hands of the respective counties on Saturday, October 11.

I am writing this at this time in order that you may be advised of the urgency of this matter and may arrange to be in Loise either in person on that date or that you may specifically authorize Mr. Baer or some other deputy to approve this report when it is submitted, affix the seal of your department and otherwise legalize the approval as may be required by law.

In this connection, the special finance committee above referred to decided that an estimate of the Normal Flow portion of the expense of the winter organization consisting of Miss Klemm, Mr. Newell and Myself and a few miscellaneous expenses should be prepared and that same should be included in the water master's bill or report for the past season, this amount to be payable to the State of

Idaho and later to be paid out on submission of proper vouchers in much the same manner as the stored water portion of the expense during the past season was handled. This decision was reached on the ground that most of the work of this winter organization would be the preparation of the annual report summarizing the work of the past season and in consequence, the expense belongs rather to this year's bill than to that of the succeeding season. The precedent for this action on a small scale was established during the year 1918 when the amount of \$250.00 was included in the bill to cover in part at least the cost of preparing the report for the 1918 season.

It is understood that the law does not specifically provide for any such procedure but since the arrangement appears to be just and apportions the cost against the interested water users in accordance with their natural flow diversions of the past season, it is believed that little objection will be raised on the part of any of the counties particularly interested. Should any of the counties, however, refuse to pay the bill on account of the inclusion of this item, they can still have no excuse for not paying the bulk of their assessment and such failure would only necessitate further arrangements on the part of this finance committee or specially interested water users to make provision for the advance of the necessary money to continue the winter organization.

Since under this plan, if no objections are raised, it will be possible as soom as the counties have settled their respective bills to reimburse those interests who advanced money for the creation of the Normal Flow Fund at the beginning of the season in full and further, since some delay will be avoided, in the completion of this program, I am proposing to suggest to the North and in the Canal Companies that they settle their portion of the bill direct south Side Canal Companies that they settle their portion of the bill direct rather than submit it to the respective counties in which their headgates are located. I believe that both Mr. Wheelow and Mr. Shepherd will favor this plan. Should there be any objection on your part or should there be anything in the State law which makes the submission of this report direct to the canty obligatory, please notify me immediately.

Dear Sir: In order to facilitate the work of the Committee of Nine which has been appointed and which has already done some work in connection with the a rangement of the new department to handle the distribution of Snake River water in District Ho. 26, it seems advisable that a Countitee of Three be appointed to be known as an executive committee, which committee will be charged with the duty of working out the details of this new arrangement and clothed with the power to call together the Committee of Nine for consultation on all matters outside of the ordinary work and which may involve the establishment of general policies. To the Committee of Nine Representing Water Users in District No. 36. State of Idaho.

Centlemen:

I am in receipt of a copy of your letter of April 28 transmitting minutes of your meeting of that date in Idaho Falls, Idaho.

The plan and recommendations outlined therein meet with the approval of this office. However, upon discussing the matter with Mr. Baldwin, the following modifications seem to be advisable for the reasons stated:

(1) The fact that Mr. Baldwin is now employed as District Engineer of the United States Ceological Survey should be utilized if possible to persuade the Director of that Bureau to establish and place Mr. Baldwin in charge of a new office of the Geological Survey located at

Idaho Falls, Kaho.
You are already aware of the fact that the last Session of the Idaho Legislature appropriated the sum of \$20,000.00 for co-operative work in connection with the United States Geological Survey in doing hydrometric work on the various streams throughout the state, and that a part of this money is and will be expended on the Snake River. In view of this fact, it seems desirable that the plan outlined in this letter be adopted so that we might avail ourselves more directly of the information obtained through the expenditure of such portions of

this \$20,000.00 fund as will properly be allowed to the Upper Snake River.

This plan would facilitate the desired centralization of supervision of water problems in district No. 36, would give all strictly hydrometric data obtained a better official status as permanent records and in addition should result in a slight decrease in the total net cost of the work to the water users through contributions of money, instruments, stationery, etc., from the funds made available for cooperative work in Idaho by the State and the Geological Survey. It would also make the organizations more flexible in regard to personnel and would doubtless eventually eliminate the necessity for office rent expense at Idaho Falls by obtaining quarters for the organization in the Federal building there.

(2) Referring to the paragraph of the minutes of your meeting relating to payment on a mileage basis for the use of privately owned automobiles: In order to avoid the difficulty and expense of purchasing cars for the official use of hydrographers it appears to me desirable to make the rate of reimbursement high enough to encourage these employees to provide their own cars. I have recently made some inquiries in regard to this matter and find that the average cost of operating cars (mostly Fords) including depreciation amounts to about 10 cents per mile upon the Minidoka project of the United States Meclamation Service and to about 12 cents per mile in the use of the Mountain States Telephone and Telegraph Co. and about

Il cents per mile in use of State of Idaho, Department of Reclamation.

I therefore suggest that you agree to 10¢ per mile as a uniform
rate for reimbursement on account of the use of personally owned cars
used on this work by either Mr. Baldwin or any of his hydrographers.

It should be understood that your plan for assessing the cost of this work against the different water users in district No. 36, including the water users on the North Fork, will still apply even though the strictly hydro etric work should be carried on under the supervision of the United States Geological Survey and that the total cost to the water users will not be materially different under either plan although under my suggested modification some saving should result and in addition it should be possible to have the Idaho Falls organization carry on practically all strictly hydrometric work in water district No. 36 which would not be possible under your original plan. It should also be understood that during the months of June, July, August and September, Mr. Baldwin would have to be furloughed from the United States Geological Survey in order to accept the appointment as my special deputy and thus comply with the State law regarding the transmission of stored water.

You will, of course, understand that if this plan is adopted the records thus obtained will become public records and will be kept or file at the branch J. S. Geological Survey office which this plan contemplates opening at Idaho Falls, in addition to being on file at the office of the Department of Reclamation at Boise, Idaho, where access may be gained thereto at any time by any of the interested parties desiring information concerning the same.

In order to avoid the necessity of calling a meeting of your consistee and losing the valuable time that would be necessary in getting you together, it has occurred to me advisable that Mr. Baldwin arrange to meet each of the members of your committee for the purpose of thoroughly considering the final plan as now outlined and as herein suggested, and I trust that you will give Mr. Baldwin such time as is necessary to a thorough consideration of this matter and hope that the plan as outlined will meet with your approval.
