WATER DISTRICT 74-W MEETING MINUTES

Chairman Thayne Kauer called the 2024 annual meeting of Water District 74-W to order at 2:06 P.M., Monday, March 4, 2024, at the Leadore Community Building, Leadore, ID with 13 members and/or representatives in attendance.

Carl Ellsworth motioned to approve the 2023 minutes as presented. Merrill Beyeler seconded. Motion carried.

FINACIAL: Chairman Kauer asked for the financial report. Treasurer Beyeler reported that with an 7-month budget for fiscal year 2023 the district received \$26,886.93 in water billing and \$0.41 in late fees with \$6.33 of interest earned on the checking account and had \$17,465.03 in expenses leaving a carryover from fiscal year 2023 of \$12,548.16 and a balance of \$12,548.16 in the checking account as of March 1, 2024. There was one late water bill. There were no calls for the heat of the day measurement. Carl Ellsworth motioned to approve of the financial report as presented. Kurt Bird seconded. Motion carried.

NEW BUSINESS

ADVISORY BOARD & CREDENTIAL COMMITTEE: Chairman Kauer called for nominations to elect the advisory board and credential committee. Merrill Beyeler motioned to retain James Whittaker, Kurt Bird, and Douglas Beyeler as the Advisory Board and Credential Committee. Chase Whittaker seconded. Motion carried. Advisory Board and Credential Committee – James Whittaker, Douglas Beyeler, and Kurt Bird.

RESOLUTIONS: Kurt Bird motioned to ad "The Advisory Board has the authority to appoint a replacement watermaster or assistant watermaster in the case the watermaster or assistant watermaster resigns or is unable to perform duties" to the resolutions. Chase Whittaker seconded. Motion carried. Kurt Bird motioned to edit the resolution on weirs to read "That the water master will require all weirs have an appropriate water measuring device and a controllable and lockable headgate." Chase Whittaker seconded. Motion carried. Carl Ellsworth motioned to accept the current resolutions as amended. Merrill Beyeler seconded. Motion Carried.

INTEREST: Carl Ellsworth motioned to retain the current interest rate of 10% on unpaid water monies. Boyd Foster seconded. Motion carried.

FIXED WAGES FOR WATER MASTER AND SECRETARY/TREASURER: James Whittaker motioned to set the wage for the Watermaster at \$900.00 per month with equipment rental for the watermaster at \$1,800.00 per month, the wage for the Assistant watermaster at \$400.00 per month with equipment rental for the assistant watermaster at \$600.00 per month and that the Secretary/Treasurer be paid \$500.00 plus \$50.00 for postage and office supplies per year. Merrill Beyeler seconded. Motion carried.

BUDGET: Carl Ellsworth motioned to set a 7-month budget of \$28,795.65 with a billing assessment of \$16,700.00 for the fiscal year 2024. Kurt Bird seconded. Motion carried.

WATER MASTER: James Whittaker motioned to nominate Kerry Purcell as watermaster. Kurt Bird seconded. Motion carried. Carl Ellsworth motioned to nominate Gerald "Red" Pierce as assistant watermaster. Merrill Beyeler seconded. Motion carried.

CHAIRMAN AND SECRETARY/TREASURER: James Whittaker motioned to retain Thayne Kauer as Chairman of Water District 74-W and retain Douglas Beyeler as Secretary/Treasurer. Kurt Bird seconded. Motion carried.

DISCUSSION and INPUT

With recent letters from IDWR on compliance of weirs and headgates Carl Ellsworth motioned to encourage users to come into compliance on weirs and headgates as requested by IDWR with Water District 170 watermaster in charge of enforcement. Kurt Bird seconded. Motion carried.

Kurt Bird recommended that if Jakes Canyon Creek is in Water District 74W it would be good to have water measured. Need to double check to see which district it is in.

As part of the Lemhi Settlement the deadline for filing on high flow rights is July 1, 2024.

Having concluded all business of Water District 74-W, Thayne Kauer adjourned the meeting 3:14 pm.
