We would like to start off by thanking everyone for the collaborative efforts yesterday and coming to visit with us onsite. We feel that this is a great start to successfully being able to reuse water here at Chobani. I wanted to share the road map that we all put together. If there is any area that needs changes please let me know.

- 1.) Chobani, in a few sentences needs to tell the DEQ what we want to do with the water that the permit is for. Water users, and a name moving forward for the water source.
- 2.) Need to provide a chemical threshold / standard for the water testing.
- 3.) QAQC (quality assurance plan) draft to be created by Chobani and submitted for review
 - a. All test methods need to be agreed upon
- 4.) Plan of Operations draft to be completed by Chobani and submitted for review
- 5.) System Maintenance plan draft to be completed by Chobani and submitted for review
- 6.) Once we have established this base line ISDA will confirm with FDA that alignment is met for the path moving forward
