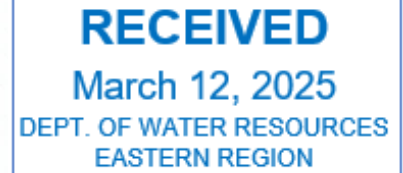

- The total volume (24 HR CFS) of water delivered to water users in the district was 1035.43 24 HR CFS. This number is derived from measured diversion and an estimate of water diverted by water users that divert less than five acres and do not require measuring devices to be installed. Estimates were calculated based on the sum total of the authorized rate of the water right x 85 days.
- Points of diversion that did not have measuring devices installed or water rights out of priority with the Snake River were curtailed. Some diversions were locked. Water users were curtailed if their priority date was junior to the priority date being delivered on the Snake River. Junior water users who leased exchange water from the Tribe for mitigation were permitted to irrigate out of priority with the Snake River. 24 water users leased mitigation water from the Tribe.
- The total expenses for the district were \$ 24,828.00.
- The total number of days I worked was 140 as of March 10th, 2025.
- Attached is the spreadsheet with my records of distribution and the Tribal delivery.

Daily delivery = total quantity of Tribal storage water to be released each day for the remainder of the rental period or season of use
= the sum of column 'AF / day'

Additional rentals of tribal water can be added at any time during the season

- Add values for 'Renter', 'AF Rented' and 'StartDate'

- 'AF / day' will calculate automatically

- 'Daily delivery' will AUTOMATICALLY update to include the additional 'AF / day' as long as the formulas in column D (AF / day) are present for each row of Renter information.

AF Rented = Total quantity of water rented by the Water User for the season

StartDate = **The first day that rented water WILL BE DIVERTED** from storage for a given Renter
= **NOT** the date that the rental agreement was made

Last day of delivery = the last day that Tribal storage water will be released on behalf of the Renters
= this date can be earlier than the end of irrigation season, to provide storage water to the water users during the period when they can put it to use.

* Once delivery of Tribal storage water begins for a given year, DO NOT CHANGE the date for 'Last day of delivery'

AF / day = 'AF Rented' volume pro-rated over the number of days between 'StartDate' and 'Last day of delivery' for a given 'Renter' (calculated for each row)
