Water District 110 Flow Meter Status

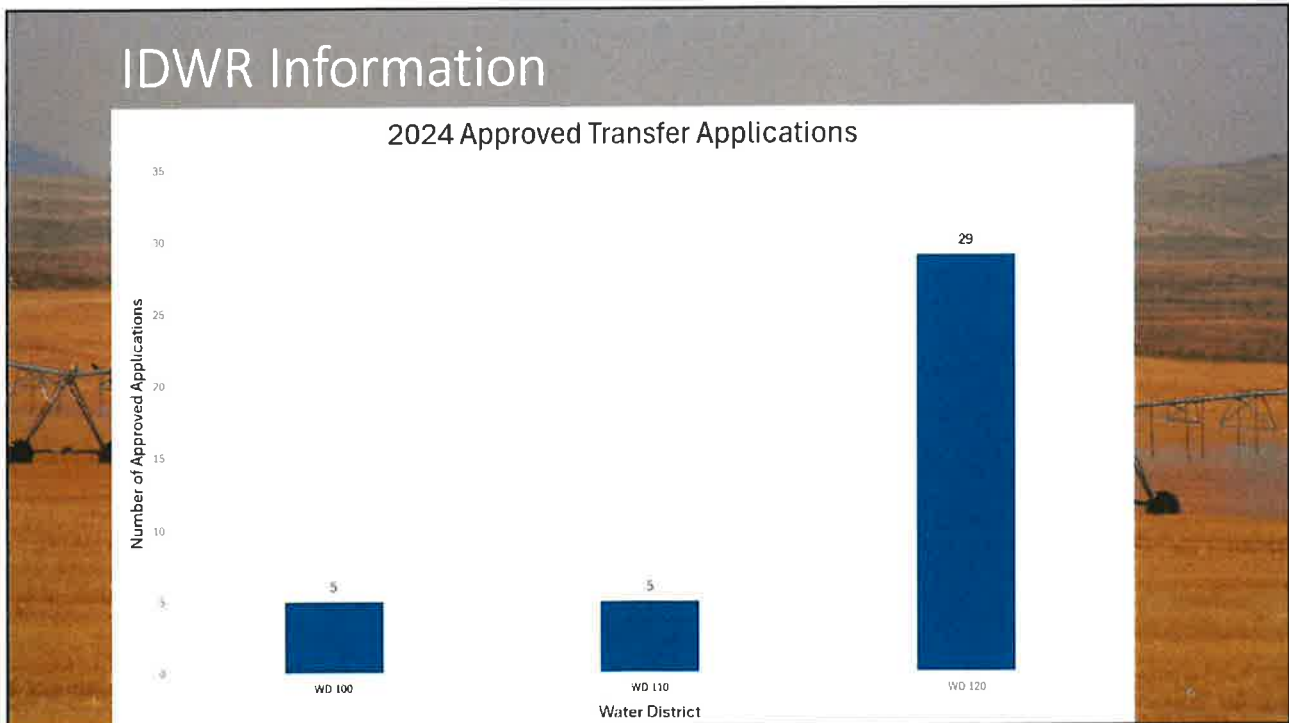

WD 110 USGS Central

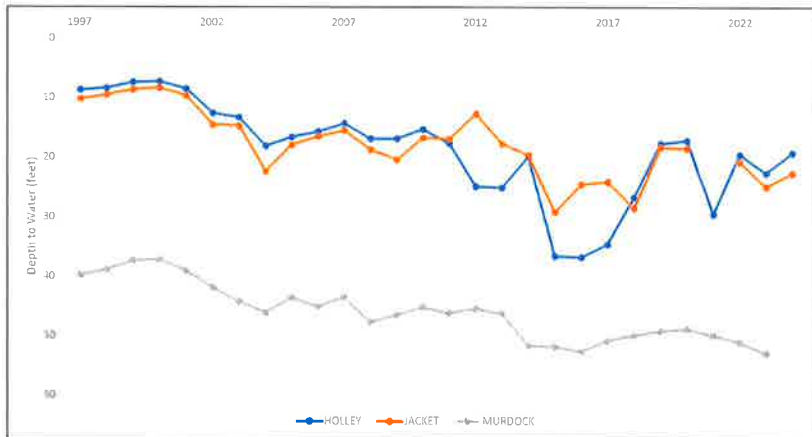


WD 110 USGS Hamer
