WATER DISTRICT 74-Z MEETING MINUTES

Chairman Steven Johnson called the 2025 annual meeting of Water District 74-Z to order at 1:12 P.M. Monday, March 3, 2025, at the Leadore City Community Building, in Leadore, ID, with seven members and/or representatives in attendance.

James Whittaker motioned to approve the 2024 minutes as presented. Ralph McRea seconded. Motion carried.

NEW BUSINESS

ADVISORY COMMITTEE: James Whittaker motioned to retain the current Advisory Board and Credentials Committee. Ralph McRea seconded. Motion carried.

Advisory Board and Credentials Committee: Jordan Whittaker, Carl Ellsworth, and Ralph McRea

WAGES FOR WATER MASTER AND SECRETARY/TREASURER: Carl Ellsworth motioned to retain the watermaster's salary of \$700.00 per month and retain equipment rental of \$1,000.00 per month and retain the Secretary/Treasurer wages of \$500.00 per year plus \$50.00 for postage and office supplies. Jordan Whittaker seconded. Motion carried.

FINANCIAL: For the 2024 Fiscal Year Water District 74Z had a seven-month budget of \$13,827.35 with a billing assessment of \$9,600.00. District 74Z received \$9,600.00 in water bills. Water District 74Z spent \$11,640.80 on expenses in 2024. The district checking account earned \$0.65 in interest. The checking account balance for Water District 74-Z for the end of the fiscal year 2024 is \$2,616.77. Carl Ellsworth motioned to accept the financial report as presented. Jordan Whittaker seconded. Motion carried.

BUDGET: Jordan Whittaker motioned to set a 7-month budget as presented of \$13,869.35 with a billing assessment of \$12,000.00 for the 2024 fiscal year. Ralph McRea seconded. Motion carried.

INTEREST: Carl Ellsworth motioned to retain the current interest rate of 10% on outstanding water monies. Jordan Whittaker seconded. Motion carried.

RESOLUTIONS: Carl Ellsworth motioned to renew the current resolutions. Jordan Whittaker seconded. Motion carried.

WATERMASTER: Carl Ellsworth motioned to retain Merritt Udy as watermaster. James Whittaker seconded. Motioned carried.

CHAIRMAN AND SECRETARY/TREASURER: Jordan Whittaker motioned to retain Steven Johnson as chairman of Water District 74-Z and retain Douglas Beyeler as Secretary/Treasurer. Carl Ellsworth seconded. Motion carried.

Having concluded all business of Water District 74-Z, Chairman Johnson adjourned the meeting at 1:30 P.M.


