The proposed amendment conflicts with Green Head's use of water under its water permit no. 63-34334 as limited by obligations set forth in the

April 30, 2022 Settlement Agreement between Green Head and Island High

High Line Ditch Company. The proposed amendment would allow Heritage

to divert more water under its permit than it is currently capable of diverting

without the proposed amendment.
