- The total volume (AF) of water delivered to water users in the district was 6,944.84 AF. This number is derived from the amount diverted through measured diversions and an estimate of water diverted by water users that divert less than five acres and do not require measuring devices to be installed. Estimates were calculated based on the acreage of the water right x 3.5 AF.
  
- Points of diversion that did not have measuring devices installed or water rights out of priority with the Snake River were curtailed. Water users were curtailed if their priority date was junior to the priority date being delivered on the Snake River. Junior water users who leased exchange water from the Tribe for mitigation were permitted to irrigate out of priority with the Snake River. 8 water users leased mitigation water from the Tribe.
  
- The total expenses for the district were \$28,704.00.
  
- The total number of days I worked was 173 as of December 22<sup>nd</sup> 2025.
