They talked about how to watch it and what they need to look for. Need to pay attention to start/end dates on well. Mike asked who polices the water, Jose said they do but they don't have the resources available to watch it closely. He said if there is a problem citizens need to submit formal complaint so there is documentation.

They discussed the diversion at Marlow's, it needs new boards and the hard water removed. Mike said he could take the backhoe up to help remove boards. He was worried that's why the gate wouldn't close all the way.

Advisory board, it was agreed to remove Keith Bitton from the board and proposed to add Vaughn, all agreed.

Marlow prosed to keep the chairman the same, Max, Vaughn seconded.

Vaughn proposed to keep Ashley as secretary Marlow seconded.

Max proposed to keep Mike as watermaster, Marlow seconded.

Next years meeting date was set to March 15, 2027 at 10am at Tingey Home again.
