Dear Water District Secretary or Watermaster,

Enclosed are several documents related to the annual water district meeting.

- 1) **Information form to provide the Idaho Department of Water Resources (IDWR) the date, time, and location of the next annual water district meeting.** Please complete the meeting information form and return it to IDWR. Upon receipt of the completed form, IDWR will send a meeting notice to each water user and interested party in the district. Meeting notices must be mailed no later than three weeks before the meeting date. Therefore, to provide IDWR adequate time to create and mail the notices, please **return the completed form to IDWR as soon as possible or at least four weeks before the meeting date.**
- 2) **IDWR's list of water right owners within your district.** This list reflects the ownership and address information currently on record with IDWR. You may notice outdated ownership or address information. We encourage you to assist owners in getting their records updated, as *all correspondence, including meeting information, will be sent to only those owners and addresses currently on record.* Address or ownership information can only be updated *by the owner* via the appropriate forms, found on the IDWR website: idwr.idaho.gov → Forms → Water Right Forms.
- 3) **Annual Meeting Checklist.** Per Idaho Code Title 42 Chapter 6 (Distribution of Water Among Appropriators), annual water district meetings must include the following actions:
 - a. Elect watermaster and fix compensation
 - i. Elect assistant watermaster and fix compensation (optional)
 - b. Choose meeting chairman and meeting secretary
 - c. Choose advisory committee (optional)
 - d. Approve budget
 - e. Set date, time, and location of next annual meeting

A checklist has been included to ensure your annual meeting includes these actions. Fill this form out during the meeting and return with the meeting minutes

If you are no longer the water district secretary or watermaster, please forward this to the current secretary or watermaster or return this correspondence to IDWR as soon as possible.
