1. The meeting was called to order at 4:02 PM by Dave Schuler. In attendance were Watermaster Joel Griffith, Secretary/Treasurer Judy Schuler, committee members - Janet Bloemeke, Arlen O'Brien, Jane Dougherty Sandstrom, Ty Cole and Dave Schuler. Public – Judy Justice
2. Motion by Janet Bloemeke to approve the March 23, 2026, meeting minutes. 2nd by Dave Schuler, motion passed.
3. Joel discussed the integration of an assistant watermaster into the operations of the district. Motion by Jane Dougherty Sandstrom to nominate an assistant watermaster. 2nd by Ty Cole. Motion passed.
4. Motion by Dave Schuler nominating Judy Justice as the assistant watermaster for LTWD 75F. 2nd by Ty Cole. Motion passed. Emails will be sent to the North Fork lateral managers advising them of Judy Justice's appointment.
5. Dave Schuler gave an update on the Kozacek water right application and IDFG/USFS protests. 8 pending water right applications will be awarded with a condition stating the permits may be revised pending the decision concerning the status of the Kozacek water right.
6. Motion by Dave Schuler setting the assistant watermaster pay at \$25.00/hour. 2nd by Ty Cole. Motion passed.
7. Dave gave an update on the annual assessments. Currently tracking down mailing addresses for several unpaid assessments.
8. Ty Cole explained the value of high-water rights and how they would benefit water users on the North Fork. Dave sent an email to Jen Vogel inquiring about the possibility/process of applying for high water rights on the North Fork.
