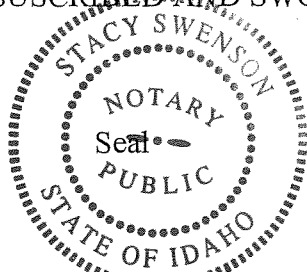

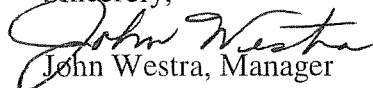
Dan Nelson at our state office will provide you with a day on-site training to familiarize you with Cold Springs Creek and wateruser diversions. I would ask that both the District Chairperson and Watermaster coordinate training directly with Mr. Nelson. The onsite training will also include inspection of the wateruser's diversion works to make sure that measurement and controlling works meet standards. Please notify waterusers of the date so there is access to all diversion locations and the ability to make inspection. Mr. Nelson's direct contact number is 387-4856.

During the irrigation delivery season, Rob Whitney or I will be your Department point contacts should you have questions or delivery issues, phone 334-2190. I would ask you avoid contacting other Department staff members as they are not familiar with district operations or have access to relative information.

Enclosed are watermaster reports that summarize the District water rights, a watermaster handbook, and daily record books. Please review with Mr. Nelson.
