Advisory Committee: Kenny moved and Randy seconded to retain the same Advisory Committee, consisting of J.C. Fry, Gene Hess and Cliff Bledsoe. All were in favor, motion passed

Cliff moved to have next year's meeting at the same time, same place. The meeting will be held at the Longbranch in Horseshoe Bend on the first Wednesday – March 05, 2014 at 11:00 am

There being no other business, Randy moved, Cliff seconded to adjourn, All in favor, meeting was adjourned at 12:04 p.m.
