#### Dear Mr. Grush:

As you recall, you recently inquired about installing sprinkler systems on the 7-Springs Ranch property, located along the west side of Highway 77, north of Connor. Dacx Duffin, provided a copy of a map showing the location of the proposed sprinkler systems on the property. A copy of this map is provided for your reference. The red outlined area on the map reflects the currently authorized place of use for the irrigation water rights on the 7-Springs Ranch property. Comparing this map and the locations of irrigated property with the water rights on the 7-Springs Ranch property indicates that there are discrepancies between the proposed irrigated lands and what is allowed according to the water rights. This is evident when comparing the following:

It should be noted that the 7-Springs Ranch property is located within the Cassia Creek Water District (43C) and many of the water rights appurtenant to the land are considered as administrable within the water district. Unauthorized diversion and use of water within a water district is subject to curtailment and the issuance of notice(s) of violation. Note that diverting water in Idaho without a valid water right is illegal pursuant to §42-351, IDAHO CODE, and pursuant to §42-1701B, IDAHO CODE, subject to civil penalties up to a maximum of \$50.000 per year. It is advisable that if you intend to irrigate the property as indicated on the map provided by Mr. Duffin then you should pursue modifying your water rights to cover all the lands intended to be irrigated. This should be done in a timely manner in order to avoid the initiation of any potential violation and subsequent enforcement actions. Note that the water rights would have to be modified to include these different lands before irrigation could legally occur on these lands.

The place of use of water rights can be modified via the water right transfer process pursuant to §42-222, IDAHO CODE. This consists of filing an application that is subject to public notice and protest. All of the irrigation water rights on the 7-Springs Ranch property would have to be included in such an application. This would include water rights 43-00368, 43-00369A, 43-00369B, 43-00370, 43-00417A, 43-00417B, and 43-07080. However, note that water rights 43-369A and water rights 43-370 are currently subject to protested transfer application # 78296 (this is the application, protested by BLM, that you filed to change the point of diversion on Sibley Creek). In order to precede with a new transfer application involving rights 43-369A and/or 43-370, protested transfer # 78296 must somehow be resolved (protest withdrawn, application withdrawn, etc.).
