The meeting was called to order at 2 p.m. by Watermaster Michael Poulton on March 3, 2020 At the Oakley Canal Office. The following members were in attendance- Michael Poulton, Jared Bedke, Kelly Adams and Jana Reeder from IDWR. WE really appreciate it when members of the IDWR. They clarify and correct items the District misinterprets.

The first order of business was to appoint officers. The method of voting was by majority vote of the water users present [Section 4, statue 42-605]. Kelly Adams was reappointed Secretary for the water year 2020. The minutes of the 2019 annual meeting were read and approved as written.

The budget was approved as the same as previous years. There is no budget monies collected. Water Right Holders maintain their own workings and measuring devices. The Watermaster approves the maintenance and controls the measurement of water. It was voted that the same resolutions adopted in the previous years be adopted for water year 2020. Michael Poulton was reappointed as the Water Master for the year 2020. The Water master presented the annual report and a copy accompanies this document.

Those present accepted the district's actions in the 2019 water year and deemed them appropriate for the 2020 water year.
