Minutes for the Annual Water Meeting District 45F Albion Senior Citizens Center March 1, 2021

DEPT OF WATER RESOURCES SOUTHERN REGION

The 2020 meeting chairman, Tom Geary called the meeting to order. Six S Ranch called for voting by the alternative method. It was determined that Six S Ranch holds 48 percent of the voting shares.

Nominations were opened for meeting chairman. Tom Geary was nominated to serve as meeting chairman. He was elected by voice vote.

David Bell was nominated to serve as secretary/treasurer. He was elected by voice vote.

The minutes from 2020 were read.

Water Master Don Gunderson presented his water master report. The water master responded a few questions and the meeting moved on to other business.

The past years financial report was read and approved. We ended the year with a surplus of \$952.45, which will be applied to the 2021 budget. A copy is attached.

The water masters proposed budget was presented and discussed. The matter of compensating the past watermaster to train the new watermaster was discussed. It was note that the department and the advisory committee had been consulted and that the compensation would not be included in the proposed budget. The department will be responsible for watermaster training. It was then proposed the budget be adopted and the measure was approved by voice vote. A copy of the budget, and its apportionment among users is attached.

The floor was opened for nominations for the advisory committee. Jeff Chatburn was nominated on Howell Creek, Nick Takas on Marsh Creek, and Leroy Robinson on Land Creek. Being no other nominations, the advisory board was elected by a voice vote.

A motion was made and adopted to accept Wells Fargo as depository for district funds.

Resolution "B", which states that no user may divert water until his water bill is paid in full unless arrangements are made in advance with the water master, was adopted. A copy is attached.

A resolution was introduce designating the "five year average method" as the method of apportioning district cost among appropriators. It was adopted. A copy is attached.

A resolution was introduced to collect interest and penalties on delinquent accounts. Interest was set at 1% per month and a 10% penalty will be assessed on all accounts not paid by Dec. 31. Resolution was adopted by voice vote. A copy is attached.

A call was made for nominations for water master. The only nomination was that of Alan Lloyd. Nominations were closed and Alan was elected by voice vote. It was determined that the term of service for the water master would be 12 months.

Earl Warthen gave a report from the Water District 140 meeting. He noted some of the changes that had been made concerning administrative matters and also provided a narrative on his views concerning water sheds in Nevada contributing to the decline of local ground water tables.

The next annual meeting was set for Monday, March 7, 2022 at 2 pm at the Albion Senior Citizen Center. Time and place were adopted by resolution, and the meeting was adjourned.

Except as provided in 1.a below:

- 1. BE IT RESOLVED, that no direh, canal company, or other water user as shown by the approved budget shall have the right to demand and receive water, and the watermaster shall not deliver to such person or persons until the amount due and payable from said water user or user's, as fixed by the approved budget, has been paid. Water must be paid on, or before April 1, each year.
- 1.a. Where circumstances dictates that a water user desires to request water delivery ahead of payment for season water, the user shall present a signed written request to the watermaster stating the circumstances for requesting delivery ahead of the scheduled delivery. If acceptable to the watermaster, the request shall be countersigned by the watermaster and retained for the record.
- 1.b. No water will be delivered to any user who has not paid his/her previous season's water bill.
- 2. BE IT RESOLVED that for the year 202/, the watermaster after beginning his term of service, shall continue in service for twelve calendar months.
