On the whole, the 2021 irrigation season was very poor due to well-below-average snow pack and sparse and infrequent summer precipitation. Even though the total district budget was approximately \$800 less than the previous year, the basin-wide stream flows were decreased significantly, leading to an elevated apportioning factor. This cost was up from \$3.7394 per unit to \$4.43216 per unit, and curtailed deliveries for most water users by late June to mid July, made 2021 a tough year for everyone.

Because this apportionment is done on a five year average, years this bad tend to work themselves out with respect to billing for individual users over time. Unfortunately, current snow pack again does not look promising for the irrigation season ahead. As we are all aware, however, significant high elevation snowfall often comes in March and April, and late-Spring rains may yet alter the outlook of our irrigation season for the better.

As Table 1, "Five Year Totals and Averages" illustrates, 2021 billable water deliveries were roughly half of the previous year, which was also a significantly below-average year. Deliveries are expressed in 24-hour second feet(1 cubic foot per second over a twenty-four hour period), equal to 1.9835 acre feet.
