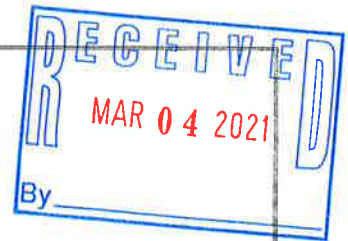


WATER DISTRICT BUDGET
