Nomination/Election of Chairman: Floor open to nominations. No other nominees. Motion was made by Royce Schwenkfelder to keep the same chairman (Ray Turnbull) as last year and all other committee members. Seconded by Mark Moura. Discussion. Passed unanimously.

Treasurer's Report: Motion was made by Royce Schwenkfelder to approve the treasurer's report as presented. Seconded by Mark Moura. Passed unanimously.

**Snowpack Measurement:** No Report.

**Electronic Devices:** More calculations are needed at the bridge.

**New Business:**

**Proposed 2021 Budget** was presented by the Treasurer. Motion was made by Mark Moura to approve the 2021 Budget as posted. Seconded by Royce Schwenkfelder. Discussion. Passed unanimously.

**Assessments for 2021:** Motion was made by Mark Moura to keep the assessments same as last year at \$50.00 per CFS and a minimum of \$5.00 for 2021. Seconded by Royce Schwenkfelder. Discussion. Passed unanimously.

**Nominations/Election of Secretary/Treasurer:** Motion was made by Ray Turnbull to retain Kathy Davis as secretary/treasurer for 2021 with the same salary of \$1000.00 (\$600.00 salary and \$400 for mileage and expenses). Royce Schwenkfelder moved nominations cease and seconded motion. Discussion. Passed unanimously.

**Nominations/Election of Water Master:** Floor was open for nominations. The chairman introduced Howard Stohlman and stated the Little Weiser Irrigation District had hired him as their wastermaster. Nominations open. Motion was made by Royce Schwenkfelder to nominate Howard Stohlman as Water Master for 2021. Seconded by Mark Moura. Discussion was held. LWID is paying Watermaster Howard Stohlman \$7,500.00 and paying \$500.00 to Clifford Crossley as an advisory capacity for 2021 and mileage the same at \$1.00 per mile. It was agreed to keep the same pay as the Little Weiser Irrigation District for the Howard Stohlman and Clifford Crossley. Passed unanimously.

Next meeting is set for February 1, 2022.

As no other business was presented. Royce Schwenkfelder moved to adjourn the meeting. Seconded by Mark Moura. The Chairman adjourned the meeting at 1:40 P.M.
