## Annual Meeting of the Idaho Water District 11-F February 26, 2020 Geneva, Idaho

Devin Boehme started the meeting at 7:00 pm on February 26, 2020 held at the Geneva LDS church. Devin asked the secretary to read the 2019 minutes. The motion was made to accept the 2019 minutes by Garth and seconded by Kris. The motion was made by Garth to accept the 2020 agenda. Kris seconded the motion. Both motions passed.

First on the agenda is the election. The water master position had two people nominated. Garth made the motion to cease nominations, seconded by Gary. The first was Carmela Rigby; the second one was Joel Teuscher. The two people nominated were asked to leave the room. Then a hand vote was taken. 2 votes for were for Carmela, and 5 votes for Joel. Joel was retained for the water master position. The motion to retain the present secretary/treasurer was made by Garth and seconded by Richard. The motion passed. Devin was the only member up for election. The motion was made to retain Devin on the Board by Gary seconded by Garth. The motion passed.

Joel went over the report from 2019 water year. He went over that the adjudication will pass this year in the Bear River basin. Carmela asked what the adjudication was about. Joel explains that the water rights here went through the lawsuit in 1902. And that the water here is should be in good shape. You need to be sure your water rights are up to date. The Snake River adjudication was brought up. It was brought up those users in the Snake River basin lost water. Joel asked the secretary to send out the description of each shareholder water rights in their assessments. When you start up using the water or shut off write it down because Joel does not get around all the time to see when you are using the water. Then give it to Joel. Please pay the assessments before the water is turned into the ditches. Also please spray and cleanup the diversion spots.

The water cost was \$.38 to deliver in 2019. James printed out the wrong page. The funds spent in 2019 are \$4,999.18. The estimated expenses for 2020 are \$5,415.00. The estimated income for 2020 is \$5,874.99

Garth made the motion to accept the budget, seconded by Gary. It passed.

Motion to made to close meeting by Victor and seconded by Reed. The meeting adjourned.
