Potential Reduction in 2002 Water Use

IDWR water managers are cautioning ground water users in five southern Idaho ground water districts that a poor water supply outlook means they may have to curtail their water use by up to 15 percent this year because they will not be able to meet their obligation to supply replacement water to senior surface water users.

IDWR Director Karl J. Dreher issued the caution in letters sent to 1,500-2,000 ground water users who make up the Aberdeen-American Falls, Bingham, Bonneville-Jefferson, North Snake and Magic Valley ground water districts.

Ground water users in the five districts agreed late last year to provide surface water to surface water users with senior water rights as a replacement for ground water being pumped. The agreements required the Aberdeen-American Falls, Bingham and Bonneville-Jefferson districts to supply a total of 28,500 acre feet of water. The North Snake and Magic Valley districts were to supply a total of 40,000 acre feet of water.

The agreements also stipulate that the North Snake and Magic Valley districts to reduce pumping by up to 10 percent and the other three districts by up to 15 percent if replacement surface water is not available.

Below-average snow pack in the Upper Snake River system, combined with limited carryover water from last year, means it is probable there will not be surface water available in the Idaho water bank to meet the obligation.

Therefore, absent an agreed-upon substitute for the replacement water, ground water diversions will have to be reduced pursuant to the stipulated agreement. The extent of any reduction will depend in the end on the amount of any replacement water that is secured for rental.

The records of the Idaho Department of Water Resources ("Department") indicate that you own one or more water rights for the use of ground water within Water District 120 and the American Falls Ground Water Management Area (GWMA). Department records do not indicate that out-of-priority diversion and use of water under your water right(s) is covered by either an approved mitigation plan or one of the stipulated agreements negotiated last year by the Aberdeen-American Falls, Bingham, and Bonneville-Jefferson Ground Water Districts, and certain municipal and industrial water users.

Because of severe drought conditions persisting across the Upper Snake River Basin, the American Falls GWMA was established last August. This allowed the Department to seek curtailment of relatively junior priority ground water diversions from the Eastern Snake Plain Aquifer ("ESPA") that further reduce the water supply available to senior priority water rights from the Snake River. The order designating the American Falls GWMA identified the boundary of an area varying in width from 1 6 kilometers to 5 kilometers along both sides of the Shelley to Minidoka reach of the Snake River, within which use of ground water rights having priority dates later in time than October 11, 1900, were determined by the Department to be injuring senior priority surface water rights from the Snake River. Within this area, curtailing ground water diversions will increase gains to the Snake River by an amount equal to 50 percent or more of the associated ground water depletions within 6 months of curtailment. This determination was made using the results from the Department's ESPA regional ground water flow model

On February 19, 2002, a Final Order was issued creating Water District 120 for the administration of rights to the use of ground water and springs discharging from the ESPA in the American Falls area. The first annual Water District 120 meeting was held on April 22, 2002, at which a watermaster was elected and certain resolutions were adopted.

On March 27, 2002, the Department sent a letter to you and others within Water District 120 who had water rights that were not afforded the "safe harbor" provided by an approved mitigation plan or one of the stipulated agreements negotiated last year by either the ground water districts or a group of municipal and industrial users. That letter notified right holders that the Department, through Water District 120, might need to take action to curtail diversions not covered by a stipulated agreement or an approved mitigation plan where the Department has determined that such diversions are causing injury to senior priority water rights

Unfortunately, drought conditions continue to persist across southern Idaho and the Snake River plain, and flows in the Shelley to Minidoka reach of the Snake River are similar to last year. Therefore, certain Snake River senior water rights that were calling for water last year are again not being satisfied during parts of this year. As described above, the Department, through use of its ESPA ground water model, has determined that unmitigated ground water pumping in the area of impact is causing injury to the holders of senior priority water rights from the Snake River. Consequently, in accordance with Idaho Code §§ 42-237a g. and 42-607 it is necessary to seek curtailment of all junior priority ground water rights within the American Falls impact area that are not covered by an approved mitigation plan or stipulated agreement.

Because the water right you hold is located in Water District 120 and the American Falls GWMA impact area and is not covered by an approved mitigation plan or one of the stipulated agreements negotiated by either the ground water districts or the group of municipal and industrial water users, you are hereby notified that the watermaster for Water District 120 has been instructed to curtail diversion and use of ground water under your water right for the remainder of this irrigation season. The watermaster for Water District 120 will contact you after 14 days from the date of this letter to arrange for the curtailment of the diversion and use of ground water under your water right. The watermaster will allow you reasonable time to make adjustments or arrangements to minimize hardships caused by this action. Unless water supply conditions dramatically improve, I anticipate that curtailment will need to be extended for all of next year's irrigation season.

I regret that this action is necessary. You may want to consider joining one of the ground water districts that has signed a stipulated agreement as an alternative to having your use of ground water curtailed.
