WHEREAS, the Twin Lakes Water District No. 95-C has utilized the services of Kootenai County for payment of water district expenses pursuant to Idaho Code § 42-619, and;

WHEREAS, the Kootenai County Board of Commissioners has been advised by the Kootenai County Auditor's Office that providing the service of payment of water district expenses by the County is now constituting an undue burden upon the County;

NOW, THEREFORE, BE IT HEREBY RESOLVED that Kootenai County shall no longer provide the service of payment of water district expenses to Twin Lakes Water District No. 95-C, beginning on January 1, 1997, or at such earlier time as the Twin Lakes Water District No. 95-C can assume control over funds belonging to the Twin Lakes Water District No. 95-C which are presently in the custody of Kootenai County.

IT IS FURTHER RESOLVED that a certified copy of this resolution be mailed to the Director of the Department of Water Resources prior to December 1, 1996.
