
Enclosed is a copy of the list submitted for the 1996 special assessments for the Twin Lakes Water District.

If I can be of further assistance, please feel free to contact me at this office.

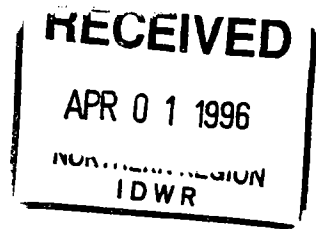

President; Diane Parks nominated by Chet Parks, 2nd by Carol Kinsey. Sec cast an elective ballot



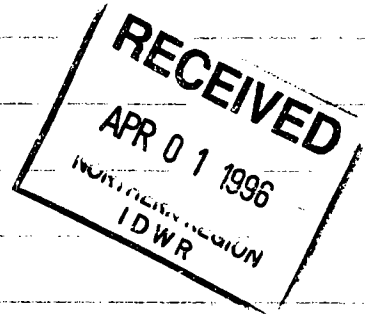

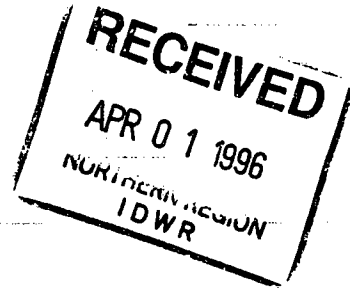
