## Minutes of Water District 11 A Eight Mile - Bailey Creek March 5, 2001

There were five water users at the meeting.

The meeting was brought to order by Donald Monroe.

Mark Harris was selected as Chairman and Secretary of the meeting.

A vote was taken for fixed compensation to be paid the Water master and Assistant.

The water master assessments are \$60.00 plus \$20.00 call out fee, if called.

The Secretary assessments are \$50.00 and work men compensation is \$300.00.

The total cost is \$410.00.

The vote was unanimous in favor of this proposal.

The Following proposals were made:

Water users deliver their own water and be checked by the Water master.

The vote was unanimous in favor of this proposal.

The water assessment is to be paid on water owned.

The vote was unanimous in favor of this proposal.

A Flat fee of \$5.00 for Thirteen of the small water users.

The vote was unanimous in favor of this proposal.

Budget for 2001 will be \$410.00 total.

\$60.00 plus \$20.00 call out fee, if called by water users.

\$50.00 for secretary and \$300.00 for work men compensation.

The vote was unanimous in favor of this proposal.

The Water master duties start 4-15-2001, end 12-1-2001.

The vote was unanimous in favor of this proposal.

Keep enough money with County Treasure to pay for work men compensation.

The vote was unanimous in favor of this proposal.

Vote for Water master and Secretary for the season of 2001.

Dusty Moore proposed Donald Monroe for Water master and Secretary.

Mark Harris seconded the motion.

The vote was unanimous in favor of the proposal.

Allen Munro, Mark Harris and Dusty Moore were selected

For the advisory committee.

The vote was unanimous in favor of this proposal.

If Water master is required to go to Seminar, how do we want

To assess the cost of the Seminar?

Add cost into next years budget of each water owner.

When ditches or canals are to be cleaned, if there is a charge
