ADOPTED AT THE ANNUAL MEETING OF THE WATER USERS OF

WATER DISTRICT No. 75-D

1. THE COUNTY AUDITOR AND TREASURER WILL COLLECT THE ASSESSMENTS AND SEND THEM TO THE WATER DISTRICT TREASURER, (CHARLES R. MORTON) BOX 133 CARMEN, N.M. WHO WILL HOLD AND DISPERSE THE FUNDS.
