The minutes of the last meeting were read & approved.

#### CREDENTIALS COMMITTEE

The following members were nominated for membership on the Advisory and Credentials Committee: Jim Juza, Gary Powers, Dale/Edgar Edwards, and Joe Proksch.

Jim Juza declined because with his job is is gone much of the summer. It was moved by Stan Davis and seconded by Joe Proksch that we have four members on the committee at this time. It was passed unanimously.

#### BUDGET

By unanimous vote the budget in the same amount as the previous year was approved for this year.

#### WATER MASTER SELECTION

It was moved by Edgar Edwards and seconded by Francis DeMond, Arrowhead Water District rep, that Darrell Aldous serve as water master for the summer. It was moved by Stan Davis, City of Salmon rep, and seconded by Bob Blackadar that Mickey Verbeck be selected as water master. It was moved by Bob Blackadar and seconded by Jim Juza that nominations be closed. By both volume users and number of users, Mickey Verbeck was elected as water master for the summer months.



4. Bob Blackadar moved that certain individual water rights not be given water due to some questions he had about the claims. The motion died for lack of a second.
