WATER	DISTRICT	No.	75-A

Resolutions adopted by the Water District, as noted in the minutes, are as follows:

- A. The annual meeting will be held the first Monday of March, 2002 at 1 P.M. at the Salmon Valley Center, Salmon, IDaho
- B. Payments are to be made by June 1, 2001, and unpaid assessments will be charged 8% interest.
- C. To withhold delivery of water until assessments are paid.
- D. To provide for water master service throughout the year.
