WATER DISTRICT 74-W MEETING MINUTES

The annual meeting of Water District 74-W was called to order at 1:10 P.M. at the Leadore City Hall by Chairman Carl Ellsworth with eleven members or representatives in attendance.

Chairman Ellsworth asked for the reading of the 1999 minutes by Secretary Aleta Johnson. Merrill Beyeler motioned to accept the minutes as correct, Tex Kauer seconded and the motion was carried.

Chairman Ellsworth asked for the Financial report. Treasurer Johnson reported that the district had \$1843.97 in the checking account as of January 31, 2000 and that the district earned \$39.79 in interest in 1999.

NEW BUSINESS

ADVISORY BOARD: Chairman Ellsworth called for nominations to be opened to elect advisory board. Blair Kauer motioned to retain the current advisory board consisting of James Whittaker, Merrill Beyeler and Jim Dartt. Milt Slavin seconded, the motion was approved by a unanimous vote.

INTEREST: Blair Kauer motioned to retain the current interest rate of 10% on unpaid water monies. Milt Slavin seconded, motioned carried by unanimous vote.

FINANCIAL: Secretary Johnson informed the members that the 1999 dividends from the Workman's Comp policy had been rolled over to the 2000 payment leaving a balance due of \$187.20, which was paid February 16, 2000. There was no outstanding water bills. Moore Creek Ranch has a credit of \$39.48 for the sale of the ranch. Moore Creek Ranch will be sent a refund.

RESOLUTIONS: A motion was made by Blair Kauer to retain the resolutions and motions from the 1991 minutes with the revisions from the 1994, 1995, 1996, and 1999 minutes. Milt Slavin seconded, the motion was unanimously passed.

CREDENTIAL COMMITTEE: Blair Kauer made a motion to elect the advisory board consisting of James Whittaker, Merrill Beyeler and Jim Dartt as the credential committee. Milt Slavin seconded, the motion was carried.

BUDGET: Chairman Ellsworth called for a discussion about changing the budget from a debit/credit base, with a five year water usage average, to using only the previous year usage as the deciding factor in what the user will pay in the next year. Average will be based on last years use for this years budget, with the adjusted debit/credit. Steve Clark motioned, no second. Discussion tabled.

The budget for the 2000 season was proposed at \$7765.00, less the carry over in the checking account and the credit/debit adjustments. James Whittaker motioned to approve the budget, Merrill Beyeler seconded, motion was unanimously carried.

WATERMASTER: Dan and Kelly Smith were the only applicants for the watermaster position. James Whittaker motioned to retain Dan and Kelly as watemasters of Water District 74-W for the 2000 season. Milt Slavin seconded. When the votes were counted there was ten yea's and one nay. The motion was carried by a unanimous vote. Dan and Kelly were retained as watermasters for the 2000 season.

CHAIRMAN AND SECRETARY/TREASURER: Blair Kauer motioned for Carl Ellsworth to retain his position as Chairman and Aleta Johnson to retain her position as Secretary/Treasurer for the Water District 74-W. Milt Slavin seconded, motioned was unanimously passed.

FIXED WAGES FOR WATERMASTER AND SECRETARY/TREASURER Motion made by Blair Kauer to retain the same wages for the watermasters and Secretary/Treasurer as were paid last year. To the watermasters a total of \$500.00 salary and \$500.00 equipment rental per month and to the secretary/treasurer \$250.00 plus \$50.00 for telephone and postage per year. Milt Slavin seconded. So Carried.

MAINTENANCE: Water Resources Bob Foster along with Dan Smith have inventoried Big Timber Creek and Texas Creek and found several weirs and head gates that needed repair or replaced. Other creeks have the same problem. They would appreciate it if the water users on the other creeks would check their head gates and weirs to see if they need to be replaced or repaired. All users were notified by certified mail.

With no old business to discuss and having concluded all business of Water District 74-W, Chairman Ellsworth adjourned the meeting at 1:57 P.M.

RETAINED RESOLUTIONS & MOTIONS FROM 1991 MINUTES WITH REVISIONS FROM THE 1994,1995,1996 AND 1999 MINUTES.

That the secretary be paid \$250.00 per year, plus \$50.00 for telephone and postage.

That the watermasters be paid \$1,000.00 per month; \$500.00 wages, \$500.00 equipment rental, withholding \$50.00 per month until end of season, at which time if all paperwork and reports are turned in to the secretary and okayed for bing turned in to the State Department of Water Resources, the watermaster shall receive the \$50.00 per month withheld, or the sum total of \$325.00. If the paperwork and reports are not completed, and the secretary has to finish them, then the secretary will receive the withheld \$50.00 per month, up to the sum of \$325.00.

That the watermaster, one advisory board member and one user of that creek get together and go up that creek and locate all head gates and weirs, so that there will be no question on that creek, of order and locations of said head gates and weirs

That the amounts payable by each water user be shown in the adopted budget become due and payable May 1st. Said amounts, if not so paid, shall bear interest at the rate of 10% when paid, until paid. That the Lemhi County Treasurer will bill and collect fund for Water District 74-W.

That the watermaster can be signed on by one user anytime after April 1st, or is automatically on duty May 1st, to serve until October 1st, after which time he can be signed on until November 1st, at the request of one water user.
