On July 27, 2006, the Department of Water Resources ("Department") approved Application for Transfer No. 72769 ("transfer") in the name of Delbert M or Donna Lenore Huges. The transfer approval authorized changes to Water Right Nos. 72-10272 and 10276 and included the following condition of approval:

The right holder shall accomplish the change authorized by this transfer within one (1) year of the date of this approval.


On May 14, 2007, Delbert Hughes requested an extension of time of 90 days for completion of the changes authorized by the transfer approval and has shown reasonable cause for the delay.

The Department should grant an extension of time in which to complete the changes authorized by the transfer approval.

IT IS, THEREFORE, HEREBY ORDERED that the time period within which Transfer No. 72769 must be accomplished is **EXTENDED** to April 1, 2008.

IT IS FURTHER HEREBY ORDERED that this extension of time does not stay the accumulation of the 5-year period associated with forfeiture of a water right for nonuse.
