The annual meeting of Water District 67-A was called to order by Lawson Howland at 1:30 P.M. on Monday, Jan. 23, 1995.

Lawson Howland and Whitney Voermans were retained as chairman and secretary- treasurer respectively for 1995.

The minutes were read and approved. Balance in the checking account is \$173.87 with the 94 taxes paid but one advertising bill for aprox. \$11.00 to be paid when recieved.

The chairman reappointed Bob Voermans, Tom Green and Ralph Yantis to the Credentials Committee for 95.

David Birchard gave a water report for the 94 water year. He also reported on problems encountered in increasing the capacity of Ben Ross up two feet.

There was discussion of the urgency of raising the reservior at this time. Issac Ward explained the proposed Galloway Dam has filed on water from the Little Weiser drainage to fill their reservoir. If we file and complete the raising of the reservoir within the prescribed time we could receive a more " senior " water right over the filing done for the Galloway Project.

Issac Ward also reported that the Little Weiser Irrigation Dist. is drafting some regulations and requirements which will help guide the watermaster.

Approval of the budget was discussed. It was noted by the treas. that the "cushion" between income and expenses is getting smaller every year. A motion was made, seconded and passed to increase the assessment from 15¢ to 17¢. This should bring in aproximatly \$450.00 more per year. A motion was made by John Holmes to raise the salary for Sec.- Treas. from \$125. to \$225. per year . The motion was seconded and passes. The watermaster salary of \$3000. will remain the same for 1995.

Other business included a suggestion from Fern Little that the watermaster might use an answering machine to make it easier to reach him. Russell Wilkerson suggested that each ditch have a representative who could rely problems to the watermaster. 30 It was decieded that we try this and if there was still a problem that and answering machine might be considered next year.



Steve Lester, of the Idaho Dept. of Water Resources, reported that some progess is being made on the rejudication with some legal decisions expected soon which should help to clarify some of the present problems.

Steve also spoke to the problems faced by the watermaster in trying to regulate water when neither headgates or weirs are present. Laws provide water delivery to ditches with these devices installed and allow the watermaster to refuse delivery to ditches without headgates or even assess the water users a penalty depending on the situation.

Next order of business was election of watermaster for 1995. There were six people running for the job. They were: Norma Radcliff, Joe Holmes, Dick Kretten, Darren coriell, David Bichard and John Camp. Voting was done by water shares and the Credentials Committee decided to honor proxies from water users not able to attend the meeting. The present watermaster, David Bichard, was reelected for 1995.

Next years meeting will be the fourth monday in Jan.

There being no further business. Lawson adjourned the meeting at 4 P.M.
