Watermaster called yesterday with number of questions that we discussed at length (from about 4:20 to 5:30!!). Anyway, wanted to let you know that he said storage water will be depleted in a few days & very little natural flow remains. We discussed the futile call concept because WM thinks that natural flow will be insufficient to reach #1 headgate. He will try to deliver #1 when storage gone but, if unsuccessful, may need to deliver upstream instead to headgates where beneficial use can be achieved. Passing this on just in case you get or hear about furious telephone calls demanding senior water which appropriately cannot be delivered. He said it has been a tough year in 67-A. The up side is that he may be more sympathetic to our urging that proper controls be installed for diversions. Can pursue that topic again at 1995 annual meeting.

Storage water gone in few days & very little natural flow left.

(1) Wilkerson - Micky Ditch - Lat. How users Assoc w/ no real controls & individual hydrants. Problem with Mrs Josephine (see Isaac Ward's previous info 6/24/94). What to do?

Needs prompt attention on water deliveries so can work in ditch.

(2) 1980 license 67-07494 - is pld via above ditch? Appears

(3) List of names of users/ditch - has not made progress on this year but will continue to work on later. Too many problems this year to allow time for this project.

(4) Fertile calls - when not enough nat. flow to reach #1 pld, should deliver upstream to pld's where water can reach, do so in priority order. If Assoc cannot reach a pld and be put to beneficial use, is fertile call.

(5) Can irrig district (w/m also works as ditch rider for irrig district) go down a lateral & regulate withdrawals of storage flow from the ditch - or can just deliver
