RE: Water Diversion from Lakey Creek, Water District No. 67

Dear Mr. Cole:

I am responding to your letter dated August 14, 1994, in which you raised several considerations regarding your diversion from Lakey Creek tributary to Hornet Creek in the Weiser River basin.

Your letter raises four basic issues. The first is whether Article XV, Section 3 of the Constitution of the State of Idaho entitles a user of domestic water to receive water from a stream where all water in the stream is being called by a senior decreed water right for irrigation purposes. As you have correctly described, this article identifies a preference for those using water for domestic purposes. However, the article goes on to include the following language:

But the usage of such subsequent appropriators shall be subject to such provisions of law regulating the taking of private property for public and private use, as referred to in section 14 of article I of this Constitution.

The effect of this provision is to require that any subsequent domestic user who wishes to pre-empt senior irrigation water rights can do so by condemning the water and compensating the holder of the irrigation water right accordingly. This condemnation process must be conducted in a court of law.

The second issue that you raise is whether the authority of the water district and the watermaster, as identified in Chapter 6, Title 42, Idaho Code, extends to delivery of domestic water. We do not find any limitation in Chapter 6 as to the delivery authority of a watermaster based on type of use. In fact, watermasters throughout the state have delivered water for a wide variety of uses, including domestic, for scores of years in Idaho.

Your third issue regards the acquisition of a water right by adverse possession. This is not applicable in the Hornet Creek basin due to the following language in §42-607, Idaho Code:

So long as a duly elected watermaster is charged with the administration of the waters within a water district, no water user within such water district can adversely possess the right of any other water user.



Your fourth issue regards the domestic use exemption from the requirement to file water right claims. This exemption exists because most domestic water rights are from wells or springs and watermaster delivery is seldom necessary for these sources. However, if there is a situation where delivery from a source within a water district is disputed and water must be delivered to one location or another, the watermaster must deliver to decreed, licensed or permit water rights and cannot honor water rights that have not been verified in this manner by either the court or IDWR.

It is my understanding that the watermaster, Mr. Gerry Myers, conducted a test recently by sending water down the creek for about two weeks, and concluded that Lakey Creek water would not reach Hornet Creek through the stream channel due to the dryness of the year. Thus Mr. Myers, in consultation with Mr. Tuthill from our Western Regional Office, has again allowed the water to be diverted to the only known decreed water rights from Lakey Creek, presently owned by the Wallings. This letter affirms the action taken by Mr. Myers.

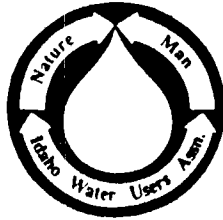
I recognize that this is a dry year and that you are seeking authorization to divert Lakey Creek water this year and in the future. Based on the Department investigation to date, it does not appear that there is a decreed, licensed or permit water right by which you can call for a delivery of water from Lakey Creek. At this time my recommendations are for you to (1) pursue the identification of a decreed water right through the Snake River Adjudication process, or (2) seek other sources of water for your uses, or (3) seek to obtain a portion of the senior irrigation water rights through a condemnation procedure. If you desire to explore any of these avenues, feel free to contact our Western Regional Office for water right identification assistance.

Re: Water Districts collection of Idaho Water Users Dues.

Dear Mr. McQueen:

Concerning our conversation at the Prehearing conference, I told you I would provide information on those Water Districts that collect Idaho Water Users Association (IWUA) dues as Water Districts. They are American Falls Reservoir District #1 and American Falls Reservoir District #2 in American Falls and Buhl, Payette Lake Reservoir Company in Payette, Water District 37 & 37 M in Shoshone, Water District 65 D in McCall, and Fremont-Madison Irrigation District in St. Anthony.

The largest Water District to collect IWUA dues is Fremont-Madison Irrigation District because they collect money from over 30 irrigation companies. They are also one of the largest water districts collecting dues for over 300,000 acres of land. Other water districts pay fees of \$100 to \$500 and have the individual canal companies and irrigation districts pay their dues. Mr. Kerner expressed concern that double payments could occur to the association. The association has a policy of returning double payments. If double payments occur, the membership list supplied by the water district is be used to return any checks or dues.

I have enclosed for you and Water District 67 a short summary of issues which will be confronting the state legislature this year. If you would like either Mr. Chapman or I to meet with you or the Water District 67 meeting please feel free to call us.
