Brief: A portion of the land within the existing company boundary is being developed for residential and recreational purposes. Some currently irrigated lands will be removed from irrigation. The transfer proposes expanding the Company boundary to allow irrigation of new lands. No change in total irrigated area is proposed.

The subject area is located South of McCall on the East side of Farm to Market road.

Contact person for the applicant is Brian McMahan, attorney for the applicant.

Authority to File: Applicant is listed as the current owner on recently created SRBA recommendation and IDWR records.

Water Right Validity: SRBA claims were filed on these rights 8/18/1988. The SRBA staff recently reviewed the rights and submitted their recommendations to the court in June, 2000. The recommended rights are the basis for this transfer. Forfeiture does not appear to be an issue based on 1987 aerial photography.

Injury to Other Water Rights: None anticipated.

Enlargement of Use: No increase in licensed acres to be irrigated, flow rate or volume have been proposed.

Local Public Interest: No negative impacts are anticipated.

Beneficial Use/Conservation of Water Resources: Proposal is consistent with standard irrigation practices in Idaho.

Review of the application finds there is no clear inconsistency with criteria of I.C. § 42-222 preventing processing of the application.

Additional Information: Attachments A through F consists of the shareholders' ownership documentation for the proposed Company boundary expansion. The Company currently consists of three parties; John Carey, Scott and Vicki Findlay and

Alan Busby. These shareholders also have individual irrigation rights for their lands within the boundary area. The rights involved in this transfer represent storage water from Boulder Meadows Reservoir, which is filled with water from Boulder Creek.

Data entry affected the correct record.

The SRBA recommendations were objected to by the Bureau of Reclamation regarding the separate streams issue. Garrik Baxter stated that a settlement was recently submitted and that the Bureau of Reclamation did not need notified of the transfer.

The attorney signed the transfer. Power of attorney was requested 2/4/2003. (Received 2/10/03 and labeled as Attachment G)

Conditions: Assuming protests are not filed and/or other information does not contradict the above analysis, and assuming it is determined the application should be approved, the following conditions of approval should be applied:

1. Rights 65-2963 and 65-12007 when combined shall not exceed the irrigation of 350 acres.
2. Use of water under this right will be regulated by a watermaster with responsibility for the distribution of water among appropriators within a water district. At the time of this approval, this water right is within State Water District No. 65D.
3. The right holder shall maintain a measuring device and lockable controlling works of a type approved by the Department in a manner that will provide the watermaster suitable control of the diversion.
4. The period of use for the irrigation described in this approval may be extended an ending date of 10/31 provided that beneficial use of the water can be shown and other elements of the right are not exceeded. The use of water after 10/15 is subordinate to all water rights having no subordinated early or late irrigation use and a priority date earlier than the date of this approval.
5. This right when combined with all other rights shall provide no more than 0.02 cfs per acre nor more than 3.0 afa per acre at the field headgate for irrigation of the lands above.
6. Basin 65 General Provisions No. 3, the Separate Streams General Provision, does not apply to appropriations of water after October 18, 1977. This water right shall be administered as being from a separate source pursuant to Basin 65 General Provision No. 3. If the holder of this right seeks to change the right pursuant to Idaho Code § 42-222 or successor statute, nothing in this general provision shall preclude any other person or entity from demonstrating that such change in use would cause injury to its water right or from

receiving any relief provided by law in the event of injury.

7. The right holder shall accomplish the change authorized by this transfer within one (1) year of the date of this approval.

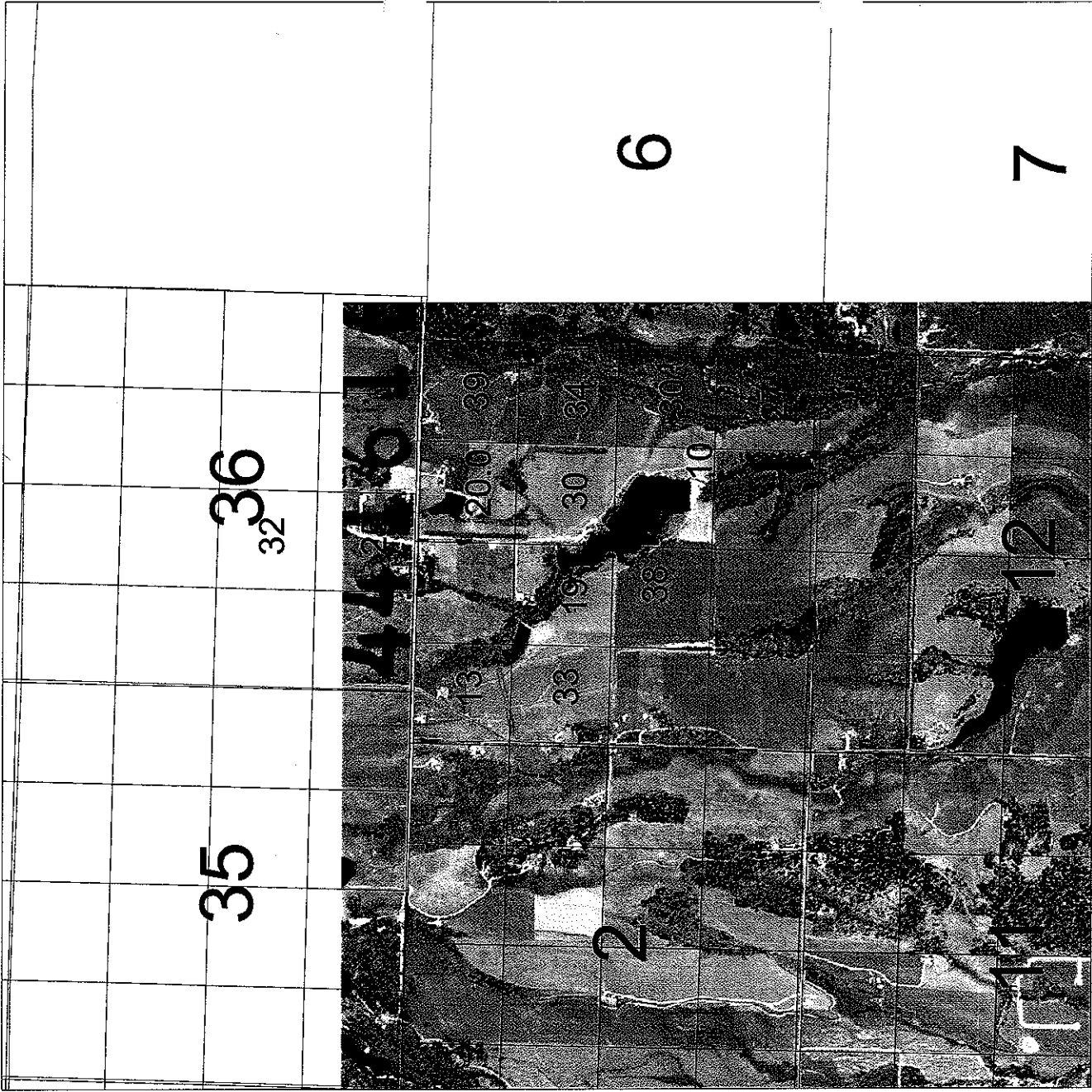

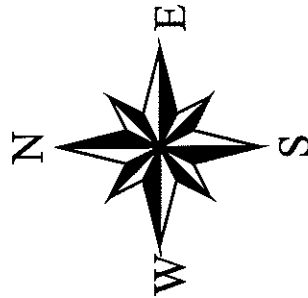
