RESOLUTION


WHEREAS, Section 42-1765, Idaho Code and IDAPA 37.02.03040, Water Supply Bank Rule 40, authorize the Idaho Water Resource Board to appoint local committees to facilitate the rental of stored water; and

WHEREAS, Water District No. 65-K has requested appointment as a local committee to facilitate the rental of water stored in Little Payette Lake; and

WHEREAS, the Department of Water Resources has reviewed the local committee procedures and lease and rental forms and has determined that the procedures and forms conform to the requirements of the Idaho Code and Water Supply Bank Rules;


NOW, THEREFORE, BE IT RESOLVED THAT Water District No. 65-K, Lake Fork Creek, whose Board members are Harvey D. Florence, Jake Maki, Harry Bettis and Herald Nokes, is appointed as the local committee to operate a rental pool for the water stored in Little Payette Lake. This appointment is effective for a period of five (5) years from the date of this resolution or until amended or revoked by action of the Idaho Water Resource Board.
