ADVISORY BOARD MEETING MINUTES WATER DISTRICT NO. 65 May 13, 2002

The Advisory Board of Water District No. 65 held a meeting at the District Office located at 102 N. Main St., Payette, Idaho on Monday, May 13, 2002 at 8:00 PM in the evening.

Those present were Rick Wells USBR, Pamela Pace IDWR, Gary Spackman IDWR, Mike Bankhead, Gene Parks, Jim Standley, Duane Pancheri, Marcia Herr, Joy Sisler, Ron Mio, Maynard Potter, Dan Surmeier, Robert Henggeler, George McClelland, Marvin Proehl, Roy Orr, Dennis Lammey and Mike McEvoy. The attendance record in its entirety is attached to these minutes.

Chairman, Gene Parks welcomed those in attendance and called the meeting to order.

<u>Minutes Approved</u>: The minutes from the Advisory Board meeting of April 8, 2002 were presented in written form to the Board Members for their review. **Dennis Lammey moved, Ron Mio seconded, to approve the minutes as presented.** Motion Carried

<u>Financial Report</u>: The Balance Sheet and the Balance Sheet Previous year comparison were presented to the Board members. Also presented was a listing of the paid and unpaid bills for the previous month. Dennis Lammey moved Mike Bankhead seconded to approve the financial report as presented. Motion carried.

Water Year Forecast, April 1, Report: Rick Wells from the USBR was invited to give an update on the water Year of 2002 Mr. wells reported that the snow pack and water content for the upper lake watershed appears to be a little below normal, with a water content at Sesash of about 30 inches and the Deadwood area containing nearly 40 inches of water. This is expected to give yields of between 90 and 95% of normal. He said that they are expecting all of the upper lakes and Cascade to fill, and are reasonably certain that Deadwood Reservoir will also fill. Mr. Wells also reported that Cascade Reservoir is expected to reach its full condition in mid June. After that time releases from Cascade will be maintained near 2200 cfs and remain at this rate to about September 2. Mr. Wells stated that water shaping is not likely to be allowed this year do to a stance taken by the BPA and that the Salmon releases are expected to start around the first of July.

Report to set Reconciliation Protocol of Water Accounting Gary Spackman reported that the IDWR Has prepared a scheduled for reconciliation within the regular water accounting system. This would require a full reconciliation on a monthly basis. The 15th of the month was chosen as the best timing to suit the water districts meeting date and that the starting month would be June of each year. Mr. Spackman assured the members that a monthly reconciliation would be certain to detect any error that may occur and prevent a situation that was experienced in the 2001 water year. Mr. Spackman also suggested that possibly after the solution and correction for the previous years error is obtained and accepted that it might be prudent to have an official licensed Hydrologist stamp of approval on the document.

After Mr. Spackman's report a lot of discussion ensued. One of the concerns was that in order to insure that the individual canal companies have a good water report in time to make Rental Pool decisions by the 1st of July it would be necessary to start the reconciliation process one month earlier in May. Mr. Spackman indicated that the process could start in the month of May.

Additional discussion conveyed the concern over the unused storage and water transfers that were used to balance the water accounting in the previous correction proposal. Some of the members stated that if it is necessary to have unused storage or carryover that the logical place to have the carryover would be in the Cascade Reservoir. Pamela Pace and Gary Spackman agreed to take another look at the accounting to see if that could be accomplished and report at the June Meeting.

Water Accounting, Financial Impact. Since the IDWR agreed to come back to the June meeting with a revised report on the 2001 water accounting it was Moved By Michael McEvoy, seconded by Marvin Proehl to postpone the Financial Impact Report until the June Meeting. Motion Carried

Ron presented a contribution request from the Idaho Water Education Foundation. Ron stated that the District has contributed to this foundation in the past. Joy Sisler moved, and Jim Standley seconded to donate \$100.00 to the Idaho Water Education Foundation. Motion Carried.

Ron presented another contribution request from the Idaho Canal Safety Awareness Program. Ron also stated that the District has contributed in the past to this program. Maynard Potter moved and Mike Bankhead seconded to donate \$100.00 to the Idaho Canal Safety Awareness Program. Motion Carried.

Ron also presented a request for the NWRA Assessment. There was no action taken on this request.

Ron presented a request made by Mr. Ed Squires representing WestRock Associates, LLC. The company would like to rent 10 to 15 acre-feet of storage water from the Rental Pool, and be able to draw this water from the Cascade Reservoir. The water would be used in the construction of roads and other earth moving operations. The water would be hauled by truck from the lake to the job site. Ron reported that he had spoken with the IDWR and that such a use could be allowed if the District Board was in agreement.

Robert Henggeler moved and Michael McEvoy seconded to allow WestRock to rent 15 Acre-feet of storage water from the rental pool at the in basin rate of \$3.20 per acre-feet. Motion carried.

Ron then made a request for reimbursement of out of pocket expenses. The expenses were for fuel for the Pickup, service and repair of Pickup, Office Supplies, and Meeting Meals, a total of \$191.87. Documentation of the expenses was presented in the meeting packets. Maynard Potter moved and Joy Sisler seconded to reimburse Ron for the out of pocket expenses, Motion carried.

Adjournment: Seeing no further business, the Chairman declared the meeting adjourned at 9:40 p.m.


