I regret to report to you that the Motion to approve this extension failed to pass in the District meeting held last evening July 8, 2002. The District Advisory Board rules require a unanimous vote to pass a motion, if even one objecting vote is received then the issue must be brought before the entire membership of the district which usually occurs at the annual meeting.

At the question, the voice vote yielded, mostly in favor, and two votes not in favor.
