Dear Mr. Lambert,

As per our conversation on the phone I am providing you with report of my visit to your property in Round Valley, Idaho regarding a report of an injury to a water right by one of the water users on the unnamed stream, a tributary to Round Valley Creek.

The report from Mr. Tim Shields stated that the flow rate within the unnamed stream that serves his irrigation water right as well as a pond located on his property had suddenly reduced to an unusually low condition, below a rate that had been experienced in the time that he has lived on the property.

After receiving permission from you to enter your property I set an appointment with Mr. Shields and walked up the unnamed stream starting at the Shield's property. I discovered two man made diversions from the unnamed stream both located on land that is likely in your ownership. The lower (most down stream) diversion appears to have been performed with the angled blade of a dozer, and this diversion has likely been in existence for many years, as it is well overgrown with grass. To get across the stream at this point it was necessary to wade through a grassy marsh about 15 to 20 feet wide with water 2 or 3 inches in depth. The grassy marsh extended several hundred feet to the south and carried water into the stream bed of the creek to the south named Sinks also a tributary to Round Valley Creek. I was not able to determine the rate of flow that moved through this altered route; however I could see that during this time of the season when the flows are at their lowest it does reduce the mainstem flow by a significant amount.

The second (upper) diversion to the stream is a very recent development. It is located upstream of a large grassy marsh in the main stem of the Unnamed stream. It appears to have been hand dug and extends southward also towards the natural channel of the Sinks stream. The ditch was not running water the day that I visited however there was evidence that sand bags were used to dam up the flow of the unnamed stream in order to force it to enter and flow into the diverting ditch. While this diversion was active it is very likely that nearly the entire flow of the unnamed stream was caused to bypass its natural stream channel.

It is likely that the reason for the new diversion is for the purpose of stockwater for the large number of sheep that were present on your place during the day of my visit.

I have researched the water rights on this unnamed stream and found one existing irrigation water right belonging to Tim Shields and Penny Darst. There are two Stockwater Rights on the stream, one belonging to you for .02 cfs, and another belonging to Donald J. Martin for .03cfs. Your Right has a priority right of 1899, and Mr. Martins Right has a priority date of 1960. Both Stockwater Rights have priority over any irrigation right but can only be appropriated for the purpose of watering stock and during the time when livestock are present on the property.

Now, to get to the place where I detect injury to a water right, it appears that the combined effect of the two diversions from the Unnamed Stream created a condition of nearly no flow in the steam at the Shields property. Either one of the diversions alone may not have caused an alarming situation. The old existing diversion appears to draw more water than the stockwater right allows (.02 cfs or 8.97 gallons per minute). This right can only be exercised when livestock are present, as they were in this case. The second diversion could not be justified when the first diversion existed, and if the original diversion was to be curtailed to allow the second diversion, the second diversion would also be held to the .02 cfs diversion rate.

I do not see any reason that you should be prevented from exercising your stockwater right and I do not detect that Mr. Shields has any intent to complain about your right to water livestock from the unnamed stream. I do however find that the combination of the two diversions occurring simultaneously does create an injury to the downstream water rights. I further find that the continual and uncontrolled nature of the old diversion that bypasses the natural stream bed of the unnamed stream falls outside of the rights provided by the .02 cfs Stockwater Right.

I have not offered any remedies to satisfy the report of injury to a water right since I wish to inform you of the situation and then discuss it with you to understand how you view the situation. Then I hope that we may come to an agreement on a method to avoid any further reports of injury.

I am supplying some photos of what I observed during my visit with a few notes to explain what they contain. Also I have included an aerial photo of the area with a diagram that will help you locate the placement of the facilities that I have explained. I hope that I have not confused this issue and invite you to discuss the situation with me over the telephone.

Photo #3, This photograph it looking from north to the south down the cut that I assume was made a few years ago with a dozer blade. It allows a portion of the flow from the unnamed stream to cross the small rise in the terrain and end up in the lower portions of the Sinks channel. The water is traveling very slowly about 2 or 3 inches deep and about 15 feet wide.

Photo #2, This is a shot of what I referred to as the second and recent diversion. This picture was also taken from the north looking to the south. I make the assumption that this was dug to water the sheep that were present that day that I visited. When water is directed into this ditch it will also transmit the flow over the natural rise in the terrain and dump into the next stream bed bypassing the natural channel of the unnamed stream.

Photo #1, This photo is looking from the east to the west and is to show that there is evidence that the unnamed stream was dammed up to force water into the new ditch that is pictured in photo #2

Photo #4, This is another picture showing evidence that the unnamed stream was dammed up with an earthen fill plus sand bags to force the stream into the new ditch. This picture is looking form the east to the west and upstream on the unnamed stream. (I wish someone could come up with a name for the unnamed stream)


On the Arial photo I have drawn in the placement of the two diversions, and labeled them #1, the older wide cut that may have been dug with a dozer blade, and #2, the recent diversion that looks to be hand dug and possibly to water livestock and allow drier footing for the stock.
