Dear water users.

I started measuring wells in the Bancroft-Lund water district on May 19th. This was an average starting date in terms of start -up in years past. The spring was cool and wet until about the middle of June. Then it seemed as if someone hit a switch, and it became hot and dry with very little precipitation until late September.

I measured the same ten wells as last year; however, in early August my steel tape got caught in Don Rigby's well. We tried to get it loose, but were forced to leave it. I finally got the tape back in late November after moisture and gases corroded the metal at the 14'8" level allowing the tape to break. I didn't get a new tape until October that I used to finish up the measurements.

The only problem this year was the use of the Everitt Smith well by Jorgensen Farms. This well was supposed to be decommissioned in exchange for transferring the water rights to the "Y" in 2003. Jorgensen Farms were issued a notice of violation in late summer of 2007. However, at the writing of this report the well is still operational.

In conclusion, it appears that we continue to scrape by, but unless we have a good moisture year the water situation for 2008 does not look all that optimistic. At this early stage it's hard to tell, but one thing is certain. Well levels are down, and we'll need at least an average winter to recharge the aquifer.

I took my last measurement on November 30, 2007. Below is a list of my expenses while monitoring the Bancroft-Lund water district during 2007.

Dear water users,

The water year for 2006 continued to improve. The 2005 - 2006 was more traditional for the area, and resulted with good snow pack in the mountains. This coupled with a later spring similar to 2005 helped water users in the Bancroft - Lund water district.

This was the first year since 1999 that the beginning measurement on the control well located on the Holsten property was below 70 feet. Also the final reading in November was 95 feet better than 1999. It appears the aquifer is recharging with the heavy winter of 2006, and the delayed pumping thanks to the late springs of 2005 and 2006.

I continued to measure the same nine wells I measured in 2005. Water levels were noticeably better, and this resulted in few complaints from users. At the writing of this report it appears the area has adequate moisture; but the lack of snow pack in the mountains due to the mild winter could negate the progress of the last two years.

I took my last measurement on November 3, 2006. Below is a list of my expenses while monitoring the Bancroft – Lund water district during 2006.
