
Sections 42-613 and 42-617, Idaho Code Annotated, provide:

Minutes of the annual Water Users Meeting of Water District 13-R held at 8:00 pm, March 06, 1995, at the home of Marion Olson, Oxford, Idaho.

Those in attendance were: James P. Boyce (setting in for James D. Boyce), Clark Cox, Claire Hatch, Ronald Mithu, Marion Olson, James Roberts, Benny Kendall, Claude Richins, and Stanton Yearsley.

Clark Cox was elected Chairman to conduct the meeting. James D. Boyce was elected Secretary.

Minutes of previous meeting were read and approved and a financial report was given showing one account of Darwin Sorensen unpaid.

A motion was made, seconded and carried by vote that the Water Master salary remain the same at \$1,550.00 annually, and Secretary remaining at \$100.00 annually. It was also voted that the budget remain at \$2,010.00. If any unusual expenses arise, the water users will be assessed proportionately.

Resolutions pertaining to collection of the budget adopted as per Idaho Code Section 46-618, which provides in part, authorization to the Water Master to withhold water deliveries or suspend water deliveries in the event delivery has commenced, from those users who have not paid their pro-rata share of the cost of operating the District as levied until such time as said pro-rata share of the cost is paid. Also Section 42-619 Sub-11; the Water Master shall be authorized to act as Water District Treasurer and collect the unpaid bill from the water user directly before delivering water. Due date of all 1995 assessments to be June 01, 1995.


Marion Olson was nominated, seconded for Water Master. There being no other names nominated, Marion Olson was elected by acclamation.
