Minutes of the Meeting of Water District 13-R
March 24, 2005
Clifton Community Center, Clifton, ID 82338

The Meeting was called to order by Clark Cox. The minutes from 2004 meeting were read & discussed & approved.

Water share users & guests in attendance were: Brett Yearsley, Benny Kendall, Marion Olson, Clark Cox, Jim Roberts, Rob Richens, Rob Bundie, Mike McMullins, Rita Valles, Nola Garner.

Resolutions adopted, pertaining to collection of the budget as per Idaho Code 46-618, which provides in part authorization to the Water Master to withhold water deliveries or suspend water deliveries, in the event the delivery has commenced, from those users who have not paid their pro-rata share of the cost of operating the District as levied, until such time as their pro-rata share is paid. Also Section 442-619 Sub. 11: the Water Master shall be authorized to act as Water District Treasurer and collect the unpaid water bill directly from the water user before delivering water. Due date of all 2005 assessments to be June 1, 2005.

The budget was presented for 2005, same as 2004, approved unanimously. With payment to ditch riders North and South \$150.00, Bar Z \$50.00, Water Master \$650.00. Motioned and second and approved. Claire Hatch put in as Water Master, Secretary. All in favor of 3 day notice of water trading motion, made to keep same representatives on ditches.

Talked about putting in new headgates at points of diversion. Three on Oxford North ditch, one for Marion, Jr., Gary Baker, Fish & Game & Jr's.

Clark motioned cleaning ditch, & repair of main ditch. The company will pay. Personal needs will be paid by each person. All were in favor.

Motion made by Clark & Benny, water being used by other people needs to have a paper of record to use other people's water. Do this every year. This needs to be done by 1 April.

Clark made motion to upgrade head gates on North ditch, approved.

Marion motioned to adjourn. Brett second it. Meeting adjourned.
