The irrigators of Water district 13-S met at the Williams Ward Church in Niter 2;00 p.m., Saturday, March 7, 1998. Irrigators present were DeWayne Mendenhall, Daniel and Roger Mickelson, Frank Swenson, Glenn Turner, and Martha Bassett.

Last year's chairman Daniel Mickelson called the meeting to order. The ninutes of last year's meeting were read and approved by a motion from Glenn and a second from Roger. Motion carried. Frank moved we spend the rules and retain the present chairman secretary, and watermaster. Roger seconded the motion. Motion carried.
