Subject: Delivery call to satisfy water right 13-02312, priority date 08/08/1962


We request the administration of water rights under the prior appropriation doctrine in Water District 13 commonly known as the Bancroft - Lund Area. We ask for a response in accordance with Rule 40 from the Idaho Administrative Procedure Act 37, title 03, chapter 11.

In response to Rule 42 of IDAPA, Act 37, title 03, chapter 11, effort has been used at our expense to divert water from the source. The water distribution system on the land has been redesigned to assist in the fluctuation of the water level. Also a pumping station and mainline has been installed to supplement this water right from the West Branch Canal resulting in a shortage of water supply available for farms that should be watered from the canal system. Expense has been applied to having a hydrologist prepare a report of water availability in this area. It has been determined from private hydrological reports and from the adjudication process involved in forming this district that well interference is a factor.

One intent of this delivery call is to allow all involved the knowledge of its existence prior to the investment in crops for the 1996 growing season. From past experience of not less than 18 years, we know the water supply will decrease in June or sooner.


I request the administration of water rights under the prior appropriation doctrine for Water District 13, commonly known as the, "Bancroft - Lund Area." I ask for a response in accordance with Rule 40 from the Idaho Administrative Procedure Act 37, title 03, chapter 11.

Over six wells have been drilled, the well has been deepened and restructured, and expense has been applied to have a hydrologist prepare a report of water availability in this area. It has been determined from private hydrological reports and from the adjudication process involved in forming this district that well interference is a factor.

I request the administration of water rights under the prior appropriation doctrine for Water District 13, commonly known as the "Bancroft - Lund Area." I ask for a response in accordance with Rule 40 from the Idaho Administrative Procedure Act 37, title 03, chapter 11.

In response to Rule 42 of IDAPA, Act 37, title 03, chapter 11, I submit the following. Since 1990 I have deepened my well and put in two different pumps. I have gone to great expense to try to get irrigation water for this acreage. Since 1978 the water level has gradually dropped, 50 ft in total. I now have only a few ft. of water on top of a blue clay layer of great depth and am unable to get sufficient water to irrigate during June - Aug. period. At times I am also unable to get good domestic water during the peak irrigation season. I have observed when several adjoining irrigation wells around me start pumping my water goes away.

From past experience the last several years, I know the water supply will decrease in late June or sooner.
