 did have pressure problems in about late July of this yr.
 could only run 1 pivot which is 1/2 of
 what they could irrigate or normally do.
 normally run 2 pivots.
 Not sure if flow meters works any longer.
 Curtis did not contact Craig about problem,
 they were able to manage problem at base on what crop type rd.

~~Stogard~~ does maintain pressure gage. PSI = 65 ~~at~~ @
 @ pump when pressure 2 pivots. WAS a gradual
 decline in psi, had to gradually make adjustments
 on valves to get psi up until they left
 to rd = 1st. When pressure 2 pivots they
 normally run 2 pivots, so they
 they just kept opening valve more as time. PSI gage
 is below value.

Note: Did not have the problem since last
 2 yrs. this is their set pt. per threshold.

Curtis had some wts. about water costs. what he did,
 why he should be doing. I explained budget, ability,
 duties.

CHAD Neibaur - Gem Valley Farms
Stanton Well

- used to be set for WL's & sub sets.
Now runs 3 pivots from this well,
this runs 3 full size pivots (1 is a windshield)
does sometimes run 2 together - but sports under
all 3 this year. He did not experience
pressure or air problems. This well is
always valved slightly.

Drying brought - he lowered pump to about
20 ft? Also re-did bowls - fans not really
had problems since.

Pauls well - this ran really well this yr,
may have had a little psi reduction but nothing
significant.

House well (Behind sheds) - no problem here really
either - may have had some psi reduction
since he adjusted valve a little - always valved
significantly - did tweak w/ psi adjustments

Hoshunay - Deep wells - no problem

Hanson well
- New well - bowls were replaced \approx 3rd week
of July - does use both wells
each well has its own power meter.

two new well w/ 1 pivot, & two
Both wells w/ 2 pivots. may have had
a little psi redxn. on both wells.

Paul's well & Home place wells - pumps were
lowered - Home well - bowls were re-sized.

Deep well - bowls were also re-sized on this.

During Drought - all but Christensen well were

psi was down to 55 psi, said he couldn't
get psi ^{H₂O} to mini pivots

ML from well runs $\approx > 1/2$ mi to mini-pivot
may have high friction losses \rightarrow only @ 4" mb to

has to run all pivots together.

Chad suggesting that maybe problems are due to system
design.

Perhaps we should suggest an independent energy pump efficiency
test of this well - Ask Power or other independent consultant,
maybe Bruce do before retiring, or contract w/ Bruce
in June/July.

WARREN

CRAIG
^ called CRAIG July 12, WARREN said PSI ^{had been} ~~was~~ down to 50 psi, but when CRAIG got there, gauge was 70. WARREN said Keith's psi was down, looked @ Keith's - psi was varying - couldn't tell real psi. CRAIG re-visited ^{3 to 4} ~~several~~ times > 7/12 BUT ^{on log well} all these readings were \approx 70 psi - never saw low readings.

WARREN said when psi drops - he has to shut down ^{pivot} ~~end~~ - guns. On CRAIG'S forest visit - it was dark - gauge was 70 but guns were off per WARREN.

But other 3-4 times CRAIG said guns were on - he saw them on. Did not perceive any problems.

No other users called CRAIG w/ respect to problems. One of Keith's sons may have called around same time as WARREN.

CRAIG thinks that food year - everything was pretty good.

As for unauthorized uses, CRAIG found none -

- CRAIG think Chris Irving. toll circle in early season by deep well - definitely not Irving's. Could not prove.
- west of ^{the} home place well - small ^{of Chris's} piece WARREN was concerned about - Burke & Jane investigated & found it was OK?
