MINUTES OF THE REGULAR MEETING
OF THE WATERUSERS OF THE BLACKFOOT RIVER WATER DISTRICT #27
OF THE STATE OF IDAHO
HELD AT THE BINGHAM COUNTY COURTHOUSE, BLACKFOOT, IDAHO
JANUARY 8, 1996

In compliance with the statute of the State of Idaho, and pursuant to the written notice from the Department of Water Resources, Boise, Idaho, owners and users of adjudicated water rights met in the Bingham County Courthouse in Blackfoot, Idaho at 2:00 p.m., January 8, 1996.

The meeting was called to order at 2:04 p.m., by Chairman Vincent Reid.

The minutes of the meeting held on January 9, 1995, were read. A motion by Zane Caldwell, seconded by La Verelle Stecklein, to approve the minutes passed unanimously.

A question was raised about the proposed Landfill in Rattlesnake Canyon and Chairman Reid stated that another delegation had contacted the commissioners recently, but they have made up their mind that all is safe and in order regardless of any concern about contamination of Blackfoot River water or ground water.

The 1996 proposed budget was presented by Chairman Reid. A motion by Francis Whitten, seconded by Zane Caldwell, to approve the budget passed unanimously. The budget is as follows:

A motion to retain Lola Dawn Hernandez as secretary was made by La Verelle Stecklein, seconded by Zane Caldwell, passed unanimously.

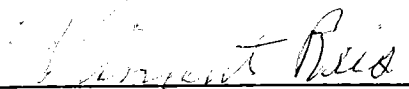

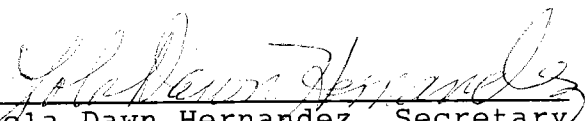
