
Sections 42-613 and 42-617, Idaho Code Annotated, provide:

If more than one county is designated then said budget shall show the amount to be collected in each county and the water users from which each county shall make collection. * * * "

Minutes of the annual Water Users Meeting of Water District 13-R held at 8:00pm. March 1, 1999, at the home of James D. Boyce, Oxford, Idaho.

Those in attendance were: James D. Boyce, James Roberts, Bret Yearsley, Stanton Yearsley, Marion Olson, Juan Vales, Clark Cox, Curtis Cox, Jeff Baker, Benny Kendall, Claire Hatch, Chris Coburn and his boy Jason Coburn.

Benny Kendall was elected chairman, to conduct the meeting. James D. Boyce elected secretary.

Minutes of previous meeting were read and approved and a financial report was given showing a balance on hand 1-1-99 of \$887.01.

A motion was made, seconded and carried by vote, that the Water Master salary remain the same at \$1500.00 annually and the Secretary at \$100.00. It was also voted that the budget remain at \$2010.00 and if any unusual expenses arise, the water users will be assessed proportionately.

Resolutions pertaining to collection of the budget adopted as per Idaho Code 46-618, which provides in part, authorization to the Water Master to withhold water deliveries or suspend water deliveries in the event that delivery has commenced, from those users who have not paid their pro-rata share of the cost of operating the District as levied, until such time as their pro-rata share is paid. Also Section 42-619 Sub.11; the Water Master shall be authorized to act as Water District Treasurer and collect the unpaid water bill directly from the water user before delivering water. Due date of all 1999 assessments to be June 1, 1999.

Some discussion was held regarding headgates and a motion passed that all point of diversion headgates that need repair or replacement shall be done within a two year limit or water will be withheld from the users that benefit from that diversion point. The cost to be allocated to those users who directly benefit from that point of diversion.

It was discussed and suggested by some that the Water Master notify the water users of their water turns in writing a few days before their turn.

Marion Olson was nominated, seconded for Water Master. Benny Kendall was nominated-- (he declined). Claire Hatch was nominated (he declined). A motion was made that nominations cease and Marion Olson was elected by acclamation as the Water Master for the year 1999.

An Advisory committee was selected for 1999 consisting of Benny Kendall (South Ditch), Clark Cox (Barzee Creek), Stanton Yearsley (North Ditch), and Water Master Marion Olson.

Meeting adjourned at 9:20 p.m.
